I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: the re-appointment of an at-large member to the Water Utilities Advisory Board for a second term of three (3) years effective October 1, 2015 through September 30, 2018.

Nominee: Beverly Scott <u>Requirements:</u> Current WUD Customer Resides in Glades area of PBC <u>Seat No.</u> 10 Nominated by: Mayor Vana Comm. Valeche Comm. Abrams Comm. McKinlay Comm. Burdick Comm. Taylor

Summary: Resolution No. R2012-0904 provides for an 11 member Water Utilities Advisory Board (WUAB). The membership consists of seven (7) District members, two (2) County-wide At-Large members, one (1) Lake Region member and one (1) Royal Palm Beach At-Large member.

On September 30, 2015, Beverly Scott's term as a member of the WUAB will expire. Ms. Scott has served on the WUAB for three (3) years (1 term). She has indicated a desire to continue as a WUAB member and the Advisory Board unanimously supports their re-appointment. The Commissioners were notified of the vacancy by the Water Utilities Department on June 18, 2015. <u>Countywide (MJ)</u>

Background and Justification: The WUAB was created by the Board of County Commissioners in March 1984 to provide informed consumer advice regarding the Water Utilities Department policies, plans and programs. The WUAB reviews the Department's annual budget as well as proposed rate changes. It also makes recommendations concerning capital improvement plans, acquisitions, new technologies for improving water, wastewater and reclaimed water service, and assists in handling the Department's Administrative Hearings. The Board consists of 11 members with nine (9) seats currently filled and a diversity count of seven (7) Caucasian males, one (1) African-American male and one (1) Caucasian female.

The Chairman of the WUAB, along with Department Staff, recommends the reappointment of Beverly Scott due to her outstanding service to date. The Commissioners were notified of the vacancies by the Water Utilities Department on June 18, 2015.

RESOLUTION NO. R-2014-0457

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, RESCINDING AND REPLACING IN ITS ENTIRETY RESOLUTION R-2012-0904, RELATING TO THE WATER UTILITIES ADVISORY BOARD.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that

Section 1. Rescission of Previous Resolution.

Resolution R2012-0904 is hereby rescinded.

Section 2. Creation, Composition.

There is hereby created the Palm Beach County Water Utilities Advisory Board, hereinafter referred to as "Advisory Board." Said Advisory Board shall be composed of eleven members: seven (7) District Members, one appointed by each of the Commissioners; two (2) At-Large Members appointed by the Board of County Commissioners; one (1) Lake Region Member appointed by the Board of County Commissioners from residents of the Belle Glade, Pahokee, and South Bay (the "Glades Cities") and adjacent unincorporated areas (the "Glades Cities") who submit applications for the position; and one (1) Royal Palm Beach Member, to be appointed by the Village of Royal Palm Beach Village Council.

District and At-Large Advisory Board Members must be County residents and current customers of the Department, both at the time of their appointment to the Advisory Board and throughout the entirety of their term of membership on the Advisory Board. The Lake Region Member must be a resident of the Glades Cities or the unincorporated area immediately adjacent to one of the Glades Cities and shall be a current customer of the Department, both at the time of their appointment to the Advisory Board and throughout the entirety of their term of membership on the Advisory Board. The Royal Palm Beach Member must be a resident of Royal Palm Beach and a current customer of the Department, both at the time of their appointment to the Advisory Board and throughout the entirety of their term of membership on the Advisory Board. The Royal Palm Beach Member must be a resident of Royal Palm Beach and a current customer of the Department, both at the time of their appointment to the Advisory Board and throughout the entirety of their term of membership on the Advisory Board.

Preference for membership shall be accorded, but not limited to, those residents who are knowledgeable or possess expertise in the following areas: utilities, operations, engineering, law, planning, management, and accounting and finance.

Upon compliance with the applicable exemption provisions of Florida Statute, Chapter 112.313(12), and the Palm Beach County Code of Ethics, up to two (2) Advisory Board members may be involved in a business relationship, directly or indirectly, with the Palm Beach County Water Utilities Department. Employees of Federal, State or local agencies which have regulatory/enforcement authority over the Department's activities shall not be eligible for membership on the Advisory Board.

Section 3. Power and Duties of the Advisory Board.

The powers and duties of the Advisory Board shall include the following:

 To review existing and proposed policies, plans and programs of the Palm
 Reach County Water Utilities Department and to advise the Palm

Beach County Water Utilities Department, and to advise the Board of County Commissioners and/or the Department as to any need for modification of same;

- To review and make recommendations concerning proposed capital improvement plans and programs;
- (3) To review existing or proposed rate changes, rate structures, and the annual budget of the Water Utilities Department;
- (4) To assist in communications with other on-line customers served by the

Water Utilities Department;

Section 4. Terms, Vacancies, Removal from Board.

For members appointed/reappointed on or after March 1, 2013, terms shall be three (3) years, and members may serve no more than three (3) consecutive three (3) year terms. Terms shall begin on October 1st and end on September 30th. The terms of those members who were appointed prior to March 1, 2013 shall end on September 30 of the year in which their term expires. Vacancies on the Advisory Board shall be filled by appointment by the Board of County Commissioners of Palm Beach County (for At-Large Members and the Lake Region Member) or District

Commissioner (for District Appointments), or by the Village of Royal Palm Beach Village Council (for the Royal Palm Beach Member). Vacancies occurring during a term shall be filled for the unexpired portion of the term, and shall not count towards the members term limits.

Section 5. Meetings and Procedures.

The Advisory Board shall select its own Chair and Vice Chair at an election held at the first meeting and annually thereafter. Advisory Board meetings shall be conducted in accordance with Robert's Rules of Procedure. The Advisory Board shall schedule ten (10) regular meetings in each calendar year. The Chair shall have the power to schedule special meetings or cancel regularly scheduled meetings as the workload of the Advisory Board requires.

The Advisory Board shall keep a permanent record of its proceedings, and shall file approved minutes from its meetings with the Board of County Commissioners of Palm Beach County. All meetings, records and files of the Advisory Board shall be open and available to the public.

Section 6. Uniform Policies and Procedures of Advisory Boards.

The Advisory Board shall be subject to the uniform policies and procedures established by the Board of County Commissioners for Advisory Boards as currently set forth in Resolution R-2013-0193, as may be further amended by action of the Board of County Commissioners.

Section 7. Effective Date.

The provisions of this Resolution shall become effective upon approval by the Board of County Commissioners.



The Water Utilities Department Advisory Board (WUDAB) is composed of eleven members; seven District appointments, one member by each of the Commissioners, two At-Large Members appointed by the Board of County Commissioners (BCC), one Lake Region Member appointed by the BCC and one Royal Palm Beach Member appointed by the Village Council of Royal Palm Beach. The BCC appoints members for staggered three-year terms.

Per Resolution No.R2012-0904, candidates must be county residents and current customers of the Water Utilities Department to be eligible for appointment. The Lake Region member must be a resident of the Glades cities or unincorporated area immediately adjacent to one of the Glades cities and shall remain a current customer of the Department throughout the entirety of their term. Preference for membership shall be accorded, but not limited to, those residents who are knowledgeable or possess expertise in the following areas: utilities, operations, engineering, law, planning, management and accounting and finance.

Currently, Beverly Scott is serving on the WUDAB as a representative for the Lake Region seat. Ms. Scott served on the WUDAB for 3 years; she is both eligible for reappointment and willing to continue to serve at the direction of the Board. Staff is planning to request consideration for this appointment at the September 1, 2015 BCC meeting.

The WUDAB typically meets the last Friday of each month at 9:00 a.m., except August, November and December. A copy of the 2015 meeting schedule is attached. The current diversity of the WUDAB is White: 7 (90%) and Black: 1 (10%). The gender ratio (male:female) is 7:1.
