Background and Justification: The WUD Uniform Policies and Procedures require Standard Development Agreements to obtain concurrency for water and/or wastewater service. The terms and conditions for Standard Development Agreements are outlined in the WUD Uniform Policies and Procedures Manual. The BCC delegated the authority to execute various types of Standard Development Agreements, and related documents including Standard Indemnity Agreements to the Department Director including potable water and wastewater agreements (R93-1619); reclaimed water agreements (R96-0228); and additional conditions for potable water, wastewater, and reclaimed water agreements (R2003-0539).

The Agreements have been executed on behalf of the BCC by the County Administrator/Director of WUD in accordance with the authority delegated by the Board, and are now being submitted to the Board to receive and file.

The Agreement Authorizes the Property Owner to renew their reservation of 12 Equivalent Residential Connections (ERC's) for both potable water and wastewater for an additional five (5) years.
- B) Standard Potable Water and Wastewater Development Renewal Agreement with Jewish Communities Facilities Corp., #09-01057-000 (District 5). The Agreement authorizes the Property Owner to renew their reservation of 16.25 ERC's for both potable water and additional five (5) years.
- C) Standard Potable Water and Wastewater Development Renewal Agreement with Highland Dunes Associates Property, LLC, #11-01004-001 (District 6). The Agreement authorizes the Property Owner to renew their reservation of 2000, ERC's for both potable water and wastewater for an additional five (5) years.
