### I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to adopt**: a Resolution of the Board of County Commissioners of Palm Beach County, Florida repealing and replacing Resolution No. R-2014-1221 and enacting a new schedule of fees and fines for the Vehicle for Hire Ordinance.

**Summary**: This Resolution provides for adoption of an updated fee and fine schedule in accordance with the provisions of the Vehicle for Hire Ordinance, Palm Beach County Code, Chapter 19, Article IX. The update is necessary to implement Ordinance changes scheduled for adoption on September 22, 2015 and to incorporate fees for all vehicle for hire companies. A summary of the changes to the existing schedule of fees and fines imposed by the Division of Consumer Affairs is attached to the agenda item. This agenda item will repeal Resolution 2014-1221. On September 10, 2015, the proposed schedule of fee changes were presented to the vehicle for hire industry which includes representation from Rasier, LLC. **COUNTYWIDE** (JB)

**Background and Policy Issues**: The Vehicle for Hire provisions of the Palm Beach County Code (Code) require a schedule of fees and provides that all such fees collected shall be deposited in a separate account and shall be used exclusively to accomplish the purpose of the Code.

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA REPEALING AND REPLACING RESOLUTION NO. R-2014-1221 AND ENACTING A NEW SCHEDULE OF FEES AND FINES FOR THE VEHICLE FOR HIRE ORDINANCE.

WHEREAS, Section 125.01(1)(n), Florida Statutes, authorizes Palm Beach County to license and regulate taxis, non-taxis, and other passenger vehicles for hire that operate in the County; and

WHEREAS, the Palm Beach County Vehicle for Hire Ordinance, as codified in the Palm Beach County Code, Chapter 19, Article IX, requires certain fees to be established by resolution of the Board of County Commissioners; and

WHEREAS, Section 19-233 of the Vehicle for Hire provisions of the Palm Beach County Code require a schedule of fees and provides that all such fees collected shall be deposited in a separate account and shall be used exclusively to accomplish the purpose of the Code; and

# NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that

- A) The Vehicle for Hire fees are hereby adopted as referenced in the chart entitled Palm Beach County Code of Ordinances Vehicle for Hire Schedule of Fees Exhibit "A," attached hereto and made a part hereof.
- B) Resolution No. R-2014-1221 previously adopted for vehicle-for-hire fees is hereby repealed.

The payment of these costs would be identified through the use of a contract/agreement with a third party auditor, vehicle for hire self-certified company, and Palm Beach County Board of County Commissioners.

### **Civil Fines:**

- 1. <u>Violations of Section 19-218</u> (operating a vehicle for hire or working as a broker without a permit) <u>and Section 19-226</u> (a automobile liability insurance requirements): \$500 first offense, \$500 second offense, and \$500 third offense (with a possible mandatory court appearance).
- 2. <u>Violations of Section 19-227</u> (driver requirements): \$250 first offense, \$500 second offense and \$500 third offense (with a possible mandatory court appearance).
- 3. <u>Violations for all other Sections of the Ordinance</u>: \$150 first offense, \$300 second offense and \$500 third offense (with a possible mandatory court appearance).

The proposed fee adjustments assume the following:

- 1) All existing vehicle for hire companies will continue certification by the DCA. One new vehicle for hire company will self certify their drivers and vehicles.
- 2) The proposed fee ranges for vehicle for hire companies who self certify with less than 500 vehicles was calculated by adding 25% to the fees for vehicle for hire companies certified by the DCA. Companies that have greater than 500 vehicles, an annual fee of \$100,000 will be charged. Due to the significant impact, potential challenges in regulation, additional positions and audit costs to ensure enforcement and compliance of the Vehicle for Hire Ordinance for companies that are self certified, the 25% increase is necessary.
- 3) The proposed fee for companies certified by DCA was reduced by 15% and to offset the increase mentioned above.
- 4) The DCA will review revenue and expenses on an annual basis to determine fees charged are accurate and support necessary VFH operations.
- 5) Business permit fees may be reduced by Palm Beach County Director of Public Safety for audit costs paid for by a vehicle for hire company who self-certifies. The payment of these costs would be identified through the use of a contract/agreement with a third party auditor, vehicle for hire self-certified company, and Palm Beach County Board of County Commissioners.

#### **INSURANCE LIMITS**
