I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to:

- A. Reappoint: Nam H. Nguyen to Seat 4 on the Internal Audit Committee.
- **B.** Appoint: Roger A. Strout to Seat 3 on the Internal Audit Committee to replace Mark Burger who resigned from the Committee.

Summary: Mr. Nguyen was originally appointed to the Internal Audit Committee in August 2010. His current term expired September 30, 2015 His new term will expire September 30, 2018. Mr. Strout is currently serving as the Alternate member for the Committee. He was appointed in October 2014. Current Board policy is to promote the Alternate member to fill any vacancy left by a member whose term expires or who resigns. Since Mr. Burger's term expired September 30, 2015, Mr. Strout would serve a three year term in Seat 3 ending September 30, 2018. The Internal Audit Committee unanimously recommended these actions at its September 16, 2015. Countywide (PFK)

Background and Justification: The Audit Committee was established in August, 1987 by resolution R-87-1226. In February, 2005 the Audit Committee was restructured and a new process for approval of the two citizen members of the Committee was established by Resolution R-2005-0372. Ordinance 2010-006, adopted March 23, 2010, eliminated the former 7 member audit committee and established a new five member audit committee consisting of individuals who are independent of the County organization and have experience in business or finance; government accounting, auditing, operations or financial management; or other relevant experience.

Mr. Nguyen was originally appointed to the Internal Audit Committee in August 2010. His current term expired September 30, 2015 His new term will expire September 30, 2018. Mr. Strout is currently serving as the Alternate member for the Committee. He was appointed in October 2014. Current Board policy is to promote the Alternate member to fill any vacancy left by a member whose term expires or who resigns. Since Mr. Burger's term expired September 30, 2015, Mr. Strout would serve a three year term in Seat 3 ending September 30, 2018. The Internal Audit Committee unanimously recommended these actions at its September 16, 2015. The membership of the Internal Audit Committee will consist of three white males and one Asian-American male and one African-American female after the reappointment.

PALM BEACH COUNTY INTERNAL AUDIT COMMITTEE

BOARD APPOINTMENT APPLICATION BACKGROUND INFORMATION

The Committee was established by Ordinance 2010-006 adopted March 23, 2010 and revised by Ordinance 2012-011 adopted June 19, 2012 and Ordinance 2013-030 adopted November 19, 2013.

<u>Section 4 – Composition</u> of the Ordinance establishes the membership requirements and composition of the Committee. The Section reads as follows:

- A. The Internal Audit Committee shall be composed of five members and one alternate member appointed by the BCC and shall not include any county commissioners as members. The alternate member may only vote when another member is absent.
- B. All members shall be citizens of Palm Beach County, independent of elected and appointed county officials and employees, and not employed in any capacity by the BCC or by an entity subject to audit by the County Internal Auditor.
- C. Membership of the Internal Audit Committee will be to the greatest extent possible representative of the community-at-large and reflect the racial, gender and ethnic make-up of the community.
- D. The members' terms shall be three years and staggered so that the Internal Audit Committee annually includes a new member and members with one and two years of service. Members terms will begin on October 1 and end on September 30.
- E. Each member shall serve no more than three consecutive full terms.
- F. Committee members shall have experience in business or finance; government accounting, auditing, operations or financial management; or other relevant experience.
- G. The chair of the Internal Audit Committee will be elected by the members of the Internal Audit Committee to serve a single two year term.
- H. The committee is subject to the uniform policies and procedures established by the BCC as set forth in Resolution R-2013-0193 and amendments thereto (if any).

Current composition of the Committee is:

Seat 1: Sandra Turnquest, African-American, female

Seat 2: David Rosenstein, Vice-Chair Caucasian, male

Seat 3: Vacant

Seat 4: Nam Nguyen, CPA, Chair, Asian-American, male

Seat 5: Marc Cohn, Caucasian, male - term expires 9/30/17.

Alternate: Roger Strout, Caucasian, male - term expires 9/30/16.

Committee meeting schedule:

The Ordinance requires the Committee to meet at least quarterly.

The Committee currently meets on the third Wednesday of March, June, September and December. Additional meetings are scheduled as necessary.

Conflict Memoranda:

None have been filed by any member since establishment of the Committee in August 2010.
