I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to:

- **A)** adopt a Resolution authorizing the conveyance of the County's interest in seven (7) parcels of surplus property to the City of Belle Glade without charge pursuant to Florida Statutes Section 197.592(3), and with reservation of mineral and petroleum rights, but without rights of entry and exploration; and
- **B)** approve seven (7) County Deeds in favor of the City of Belle Glade.

Summary: The County recently acquired via tax deed escheatment seven (7) parcels located within the municipal boundaries of the City of Belle Glade with a collective assessed value of \$43,930. The parcels serve no present or future County purpose. The parcels are being conveyed to the City pursuant to Florida Statutes Section 197.592(3), which requires the conveyance of surplus property acquired by tax deed to the municipality in which it is located. The County will retain mineral and petroleum rights in accordance with Florida Statutes Section 270.11, without rights of entry and exploration. This conveyance must be approved by a Supermajority Vote (5 Commissioners). (PREM) <u>District</u> 6 (HJF)

Background and Justification: The seven (7) parcels total 0.72 acres and range in size from 0.08 acres to 0.16 acres. The total assessed value of the seven (7) parcels is \$43,930 and the parcels vary in value from \$2,624 to \$19,422. Six (6) of the parcels are vacant and one (1) parcel is improved with an uninhabitable house. PREM, in response to direction from the Real Estate Assets Task Force, has developed a program to convey to the municipalities in which they are located surplus County property which provides little opportunity to further a County function. Staff feels strongly that the most cost effective method to dispose of this property is to convey it at no cost to the City, as the municipality is in a better position to determine how this property should be used and maintained. The City's initial plan for the parcels is to possibly develop the larger parcel(s) for affordable housing while offering the smaller parcels to adjacent owners. The City is researching with the County's Department of Economic Sustainability the possibility of obtaining grant funds to demolish the uninhabitable house. Florida Statutes Section 197.592(3) authorizes the conveyance of surplus property acquired by tax deed to the municipality in which it is located. Pursuant to PPM CW-L-023, as all of the parcels are valued under \$25,000 appraisals are not required. Also, as none of the parcel values exceed \$250,000 approval of the Property Review Committee is not required. Further, as this is a transaction between the County and another governmental agency a Disclosure of Beneficial Interests is not required.



WHEREAS, the subject lands have not been previously sold, acquired for infill housing, or dedicated by the Board of County Commissioners, and shall not be conveyed to the record prior fee simple title owner; and

WHEREAS, pursuant to Florida Statute Section 270.11, the City of Belle Glade has requested that such property be conveyed without reservation of and release of the rights of entry and exploration relating to phosphate, mineral, metals petroleum rights; and

WHEREAS, the Board of County Commissioners of Palm Beach County has agreed to convey such property reserving phosphate, mineral, metals and petroleum rights but releasing any and all rights of entry and exploration relating to such rights.

I am in receipt of an email (copy enclosed) from Mr. Steve Schlamp, Palm Beach County FDO, wherein he identifies 7 lots, or "escheated tax deed parcels," located in the City of Belle Glade that the County plans to deed to the City.

Please accept this letter as confirmation that the City accepts and is requesting conveyance of these 7 parcels to the City. Most of the parcels are very small, and likely not suitable for building, but at least one appears to be adjacent to a parcel currently owned by the City. We will look into possibly placing that parcel into our Revolving Loan Fund, whereby we finance the construction of homes to low income, first-time home buyers.

For the other much smaller parcels, they are so small that they would be of no use to the City and only add to our already huge upkeep (mowing, weed control, litter issues) costs. As we have done in the past with such very small lots, we will likely offer them to adjacent home owners, with the only cost to the buyer being payment of deed prep, nominal attorney's fee, etc. (the City will not recognize any revenue from these sales).

Please keep me informed as the process moves along. Once we receive notification of the deeds having been finalized and recorded, we will move forward with offering the lots to adjacent property owners.
