MEMORANDUM OF FEE COMMENCEMENT DATE

This Memorandum of Fee Commencement Date is made as of _______, by and between Palm Beach County, Florida, a political subdivision of the State of Florida, by and through its Board of County Commissioners (the "County") and HW Spring Training Complex, LLC, a Florida Limited Liability Company (the "LLC").

WHEREAS, on October 20, 2015, the County and the LLC have entered into

WHEREAS, on October 20, 2015, the County and the LLC have entered into that certain First Restated Sports Facility Use Agreement (R2015-____) (the "Facility Use Agreement") for the operation of a Major League Baseball spring training facility; and

WHEREAS, Article 6 of the Facility Use Agreement requires the LLC pay a Team Improvement Areas Fee for use of the Major League Baseball spring training facility commencing on the Fee Commencement Date; and

WHEREAS, Article 6 of the Facility Use Agreement defines the Fee Commencement Date as the third anniversary of the issuance of the County Bonds; and

WHEREAS, the County approved the issuance of the County Bonds on October 20, 2015 contingent, however, upon receipt of the State Funding Certification Letter; and

WHEREAS, the parties agree that the Fee Commencement Date shall be the third anniversary of the date of the County's receipt of the Funding Certification Letter from the State.

NOW THEREFORE, the parties hereby agree as follows:

- 1. The foregoing recitals are true and correct and are incorporated herein by reference.
- 2. Pursuant to Section 6.1 of the Facility Use Agreement, the Fee Commencement Date is hereby established as
