BACKGROUND:

The long term lease with Vertical Bridge, LLC (Tenant) which has been in place for the Authority's property at the corner of 45th Street and Jog Road will expire on January 16, 2016. The Authority has hired a specialty appraiser to conduct a market survey on the value of this property.

The results of this survey were received in early October. Using this information, Staff was able to negotiate a new long term lease with the Tenant at a significant increase in the monthly rent. Staff recommends approval of the new lease for an initial period of five (5) years with three (3) five (5) year extensions.

BACKGROUND:

The Authority has been notified by Southern Waste Systems and Waste Management of a pending acquisition by Waste Management of certain assets of Southern Waste Systems expected to take place later this year.

This acquisition will require the assignment of six (6) contracts between Southern Waste Systems or one of its subsidiaries and the Authority to Waste Management of Florida, Inc.

This acquisition will also require the transfer to Waste Management of Florida, Inc. of three (3) SWA Operating Permits related to facilities Sun Recycling, LLC operates in Palm Beach County that process and recycle Construction and Demolition (CD) debris, Yard Trash, and Source Separated Recovered Materials. Upon the consummation of the acquisition the ownership and responsibility for these facilities will be transferred to Waste Management of Florida, Inc.

The Authority has received requests for assignment for six (6) contracts.

Biomass Processing Agreement 12-210

This contract provides for the delivery by the Authority of yard waste from the Authority's transfer stations to Sun 4 and the processing of that material by Sun Recycling, LLC. Article 24 of the Biomass Agreement requires the Authority's consent to assignment.

Designated Facility Contracts for Sun 2, Sun 3 and Sun 7

These contracts authorize these facilities located in Broward County to accept and process Construction and Demolition Debris collected within Palm Beach County pursuant to Solid Waste Authority Governing Board Resolution 94-47. Section 3.5 of the Designated Facility Contracts provides that, "All terms contained herein shall be binding upon and shall inure to the benefit of the successors and assigns of [Sun Recycling]".

Solid Waste and Recycling Franchise Agreement, Service Area 4, Agreement 14-205

This contract is the franchise collection agreement for the unincorporated southeastern area of the county. Prior to the most recent bid process, Waste Management of Florida, Inc. was the franchise hauler for most of this area. Further, during the 2013 bid process Waste Management was pre-qualified for a maximum award; therefore, in staff's view Waste Management is qualified to assume responsibility for this Agreement. Southern Waste Systems has requested assignment of the Franchise Agreement in accordance with Section 36 of the Franchise Agreement.



Solid Waste and Recycling Collection Services, Service Area 5, Agreement 14-206

This contract is the collection agreement for the unincorporated areas of the Glades entered into in accordance with the terms of the agreement between Southern Waste Systems, LLC and the City of South Bay. During the 2013 bid process Waste Management was pre-qualified for a maximum award; therefore, in staff's view Waste Management is qualified to assume responsibility for this Agreement. Southern Waste Systems has requested assignment of the Solid Waste and Recycling Collection Services Agreement in accordance with Section 40 of the agreement.

The Authority has received a request for permit transfer from the permittee for each of the above-captioned permits, and the required permit transfer fee. The General Conditions, Specific Conditions and Expiration dates of the permits all remain the same.

BACKGROUND:

The Authority completed the refurbishment of Renewable Energy Facility No. 1 (REF #1) in FY 2011. This refurbishment included the replacement of the boilers, air pollution control systems, and distributed control systems. While these components are all new, the turbine-generator and other major components of the facility are original. The Operator is responsible for the maintenance and repair of all of the refurbished components and most of the balance of the facility. The Authority accepted responsibility for the repair and replacement of several critical, and expensive, components that were not replaced, including the turbine-generator ("Schedule 13"). This was done to eliminate the need for the Operator to price the risk associated with what was believed, and is still believed, to be the eventual need to replace these components.

The turbine-generator set at REF #1 has been in service for over twenty-five (25) years. As you are aware, the Authority has procured, and will be installing, a new turbine rotor and diaphragms at REF #1 during the Spring 2016 outage. In March of 2015, representatives of Brush Electrical Machines Ltd., the original equipment manufacturer (OEM) of the generator, completed a detailed inspection of the existing electric generator. The results of this inspection indicated significant wear on several of the main components (rotor and stator). Given the inspection results and the need for the generator to function reliably for the next fifteen (15) years of the Operations and Maintenance Agreement (O&M Agreement), several options including rewinding (rebuilding) the existing rotor and stator, replacing the rotor and stator, and replacing the entire generator were considered to insure continued reliable operation of the facility.

The Authority has been approached by BRUSH Aftermarket (BRUSH) with an offer to sell to the Authority a new generator as an in-kind replacement for our existing twenty-five (25) year old generator at a discounted price of \$2.2M. The estimated installation cost is \$500,000. Associated consulting engineering costs are estimated at \$300,000. The fabrication and installation times are estimated at approximately 26 weeks and 3 weeks, respectively. The offer is contingent upon placing an order in November 2015. TG Advisors ("TGA"), a sub-consultant to our consulting engineer, Arcadis, estimates the cost of a typical stator and rotor rewind to range between \$2.1M and \$2.6M, assuming no core damage, with an additional \$350,000 for removal and installation costs. In addition, the generator would be out of service for 8 to 10 weeks resulting in significant electric energy revenue loss. Therefore, the repair cost of the generator appears to exceed the cost of a new generator under the terms presented by BRUSH.



This opportunity will allow the Authority to replace the generator on its own schedule (Spring 2017) and at a lower cost than would otherwise be possible. This opportunity will also minimize the potential for a future extended unscheduled outage due to a catastrophic failure of the generator and the subsequent energy revenue impact on the Authority and our ratepayers. Additionally, the new generator would provide higher efficiencies with the potential for increased electrical output and corresponding increased electric revenue.

Replacement of the generator will require a minor amendment to the O&M Agreement between the Authority and Palm Beach Resource Recovery Corporation (PBRRC) to include the following terms:

- The Authority would prepare and issue a Purchase Order to BRUSH for the generator to include the design, manufacture, testing, transportation, storage (if required), and OEM installation/startup/commissioning technical support.
- PBRRC would participate in the preparation of the purchase documents to insure compliance with the requirements of the O&M Agreement.
- PBRRC will procure the services of a qualified firm to complete the installation, commissioning, and startup of the generator on a cost reimbursable basis. This contract may also include transportation of the generator from local storage to the work site. The Authority would participate in the preparation of the procurement documents.
- PBRRC will be responsible for providing all in-house support required for the installation of the generator at no cost to the Authority.
- The generator would be removed from Schedule 13, relieving the Authority of any future liability relative to the maintenance and repair of the equipment.
- Upon installation and commissioning of the generator, PBRRC will be responsible for the maintenance, repair, and replacement of the generator in accordance with the terms and conditions of the O&M Agreement between the Solid Waste Authority and PBRRC.

Finally, as you are aware, the Authority has "set aside" \$18M of General Reserve funds for "REF #1 Contingencies" to cover the cost of replacing the aforementioned major components, including the generator, that were not replaced during the refurbishment (see attached Unappropriated General Reserve Balance schedule from the FY 2016 Budget; Potential Uses of Available Balance). Proceeds from this fund are available to fund the procurement and installation of the new generator.

Staff will keep the Board advised as to the status of this endeavor. In the event the nature of the transaction differs materially from what is presented herein, staff will seek further Board direction.

BUDGET IMPACT:

Up to \$3.5M transferred from the General Reserve. There is

no rate impact due to the use of General Reserve funds.
