<b>Motion and Title</b> : <b>Staff recommends motion to approve</b> : Memorandum of Understanding (MOU) with Indiantown Nonprofit Housing, Incorporated, with an expiration date of five (5) years from date of last signature, to coordinate referrals for Emergency Home Energy Assistance Program (EHEAP) clients.					
<b>Summary:</b> The purpose of this MOU is to make and accept referrals for the Weatherization Assistance Programs (WAP) in DOSS's service area. The MOU details cooperative efforts and describes the actions that will be taken by both parties to assure coordination and referrals for EHEAP clients. No County funds are required. (DOSS) Countywide except for portions of Districts 3, 4, 5, and 7 south of Hypoluxo Road (HH)					
<b>Background and Justification:</b> As part of the EHEAP program, DOSS is required to coordinate with the local WAP agency to develop a system by which elders who have received more than three (3) EHEAP benefits in an 18 month time frame and are homeowners are referred to a WAP provider. Weatherization Assistance Program provides funds to improve the energy efficiency of the homes of low-income seniors. The MOU will ensure coordination of services, avoid duplication of assistance and increase the quality of services provided to elderly participants.

#### Memorandum of Understanding

its Board of Commissioners, hereinafter referred to as the	e COUNTY, and Florida Not For Profit
Corporation Indiantown Nonprofit Housing, Incorporated	d, authorized to do business in the State
of Florida, whose address is 15516 SW Osceola Str	eet, Suite D, Indiantown, FL 34956,
hereinafter referred to as INPHI.	

### Under this Agreement, the County agrees to the following:

- a) To accept referrals from INPHI for Emergency Home Energy Assistance Program (EHEAP) services.
- b) To make referrals to INPHI for Weatherization Assistance Program (WAP) services.
- c) To notify INPHI when a referral cannot be served under EHEAP program and provide alternate referrals to consumers who are not eligible for EHEAP services.

#### Under this Agreement, the INPHI agrees to the following:

- a) To refer WAP service recipients who receive their services to DOSS for evaluation for provision of EHEAP services.
- b) To accept referrals for DOSS for WAP services.
- c) To notify DOSS when a referral cannot be severed under WAP and provide alternate referrals from DOSS for WAP services.

**Termination:** This agreement may be terminated by either party upon no less than thirty (30) calendar days notice, without cause, unless a lesser time is mutually agreed upon by both parties, in writing. Said notice shall be delivered by certified mail, return receipt requested, or in person with proof of delivery.
