I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Amendment No. 1 to the Contract for Engineering/Professional Services for the Western Region Operations Center (WROC) with Mathews Consulting, Inc. (R2014-1764) to increase the contract in the amount of \$26,633.45.

Summary: On November 18, 2014, the Board of County Commissioners (BCC) approved the Water Utilities Department (WUD) Engineering/Professional Services Contract (Contract) for design and bidding services required to construct the WROC with Mathews Consulting, Inc. Amendment No. 1 to the Contract provides for the modification of the design of the air conditioning at WROC, addition of a new diesel emergency generator and combination of the warehouse and shop buildings into a single building. The Small Business Enterprise (SBE) participation established by the SBE Ordinance (R2002-0064) is 15% overall. The Contract with Mathews Consulting, Inc. provides for SBE participation of 97% overall. Amendment No. 1 has 100% of SBE participation. The cumulative SBE participation, including Amendment No. 1, is 99.16% overall. Mathews Consulting, Inc. is a Palm Beach County company. This project is included in the FY15-16 Capital Improvement plan adopted by the BCC. (WUD Project No. 13-053) <u>District 6</u> (MJ)

Background and Justification: WUD determined that the utilization of a Construction Manager at Risk for the construction of the WROC would result in the most efficient and effective implementation of the project, necessitating an amendment to the Contract to remove the provision of bidding services from the scope of work.



AMENDMENT NO. 1 TO CONTRACT FOR ENGINEERING/PROFESSIONAL SERVICES WESTERN REGION OPERATIONS CENTER (WROC) PROJECT NO. WUD 13-053

This Amendment is made as of the day of ______20 _____, by and between Palm Beach County, a Political Subdivision of the State of Florida, by and through its Board of Commissioners, hereinafter referred to as the COUNTY, and Mathews Consulting, Inc. [] an individual, [] a partnership, [X] a corporation authorized to do business in the State of Florida, hereinafter referred to as the CONSULTANT, whose Federal I.D. is 65-0813121.

In consideration of the mutual promises contained herein, the COUNTY and the CONSULTANT agree that the Contract for Engineering/Professional Services entered into by the parties on November 18, 2014, and referenced by County Resolution Number R2014-1764 (hereinafter "the Contract"), is amended as follows:

- 1. Additional services are provided as contained in Exhibit A1 attached hereto and made a part hereof.
- 2. The compensation in R2014-1764 was a lump sum fee of \$684,282.70 plus an additional not to exceed amount of \$10,000.00 for a total of \$694,282.70. The lump sum amount is hereby increased by \$26,633.45 from \$684,282.70 to \$710,916.15 and the total compensation including the not to exceed amount of \$10,000.00 is \$720,916.15 as contained in Exhibit B1.
- 3. The project schedule as depicted in R2014-1764 is increased by 5 weeks as contained in 'Project Schedule'.
- 4. The SBE schedules 1 and 2 are contained in Exhibit C1 and are in addition to those contained in exhibit C attached hereto and made a part hereof.

All other provisions in the Contract remain unchanged and in full force and effect.

IN WITNESS WHEREOF, the Board of County Commissioners of Palm Beach County, Florida has made and executed this Amendment No. 1 on Behalf of the COUNTY and CONSULTANT has hereunto set its hand the day and year above written.

AMENDMENT NO. 1 TO CONTRACT FOR ENGINEERING/PROFESSIONAL SERVICES WESTERN REGION OPERATIONS CENTER (WROC) PROJECT NO. WUD 13-053

The SCOPE OF WORK (EXHIBIT A of R2014-1764) is hereby amended as follows:

1. Scope of services (page 1 of Exhibit A) add the following second paragraph:

"The WROC site plan was previously approved in June 2015. The amended scope includes an Agency Review Site Plan Amendment Application to Palm Beach COUNTY Planning & Zoning Division for modification to the site plan to add the chiller yard and to modify the parking stall count. The original site plan shown on Exhibit FALP-1 (page 2 of 13) will be replaced with the a revised site plan."

2. Phase 2 and 3 (page 1 of Exhibit A) the first sentence replace the words "diesel fuel piping" with the following:

"diesel fuel system for the new generator building including diesel fuel piping extending from the existing diesel fuel tanks; fuel delivery system between the tanks and generators and new submersible diesel fuel pumps and day tank"

3. Phase 2 & 3 (page 1 of Exhibit A) replace the second and third sentences with the following:

"Design the new emergency generator building to house 2 generators: the relocated generator from WTP 11 (to be relocated at a future date), as well as one new 2000 KW Tier 4 diesel emergency generator with urea injection system complying with the EPA RICE NESHAP rule for interruptible power as the FPL service is on a load control rate structure. The new and existing generators will be redundant and not operate simultaneously under this project as there is adequate capacity with a single generator to meet all of the power load demands. The generator controls I/O will be connected back to WTP 11 and Programmable Logic Controller (PLC)."

4. Task 2.1 (page 3 of Exhibit A) in the fifth paragraph replace the words "to a manifold connection to the existing force main at SR 715" with the following:

"connect to the forcemain stub located at the southeast corner of Hooker Highway and SR 715 and provide Florida Department of Transportation right-of-way permitting"

- 5. The COUNTY is planning to use Construction Manager at Risk (CMAR) for bidding and construction of the project, therefore a portion of the bidding services included in the original contract are no longer required. Credit is provided herein for these services along with deletion of the requirement to submit 90% and 100% construction cost estimates. Task 2.3 (page 4 of Exhibit A) is hereby replaced with the following:
 - 2.3 CONSULTANT shall prepare the 90% and 100% design documents consisting of mechanical, electrical and architectural drawings and specifications for the re-designed HVAC system for the Warehouse/Shop Building and for the other modification listed above. This includes the provision of the Chiller Yard to be located east of the

Generator Building. The Chiller Yard will be sized for future expansion to accommodate the future Administration Building. The civil drawings (parking, paving, water and wastewater) will be modified to include the Chiller Yard. The 90% and 100% design documents will include technical specifications required for the HVAC system.

CONSULTANT shall prepare an Opinion of Cost based on the 90% level of design for the mechanical and electrical modifications as required for the HVAC system re-design, only. The revised mechanical, electrical and civil drawings will be included in the 90% and 100% design submittal to the COUNTY.

- 6. Delete task 2.4 (page 4 of Exhibit A).
- 7. Task 2.7 (page 5 of Exhibit A) is hereby amended to add the following third paragraph

"CONSULTANT and its sub-consultant shall update the current approved Site Plan via an Agency Review Site Plan Amendment Application for the changes relative to adding the Chiller Yard. Work effort includes attendance at required pre-application meeting, coordination with COUNTY and other COUNTY Departments, preparation and submittal of the application. It is anticipated that this will be an administrative process that does not require any public hearings or notification to surrounding property owners."

- 8. The Consultant determined that the existing stormwater outfall capacity is adequate, therefore the associated design of a new outfall crossing Hooker Highway and the associated South Florida Conservancy District outfall and FDOT permits are not needed. <u>Delete associated Tasks 3.4 and 3.6 (page 5 and 6 of Exhibit A).</u>
- 9. Task 5: Bidding Services (page 6 of Exhibit A) Delete tasks 5.2 and 5.4
- 10. Assumption 9 (page 7 of Exhibit A) is replaced as follows:

"9. Palm Beach County Water Utility Minimum Engineering Standards (2015) and Minimum Engineering Design Manual will be incorporated into the water and wastewater system design."

- 11. Any reference in the original Contract to PBCWUD is changed to COUNTY.
- 12. The PROJECT SCHEDULE (page 8 of Exhibit A) is hereby deleted in its entirety and replaced with the following PROJECT SCHEDULE (AMENDMENT 1):

SCOPE:

- 1. Provide Mechanical and Electrical engineering design services associated with the following:
 - a. Following the 60% submittal, a mechanical review meeting took place on July 8th which revised direction given by the owner from split system, DX, single zone units to a chilled water / VAV system. This revision required a complete 're-do' of the 60% drawings of the O&M, shop, and Warehouse areas.
 - b. Mechanical drawings will also be revised to include a chiller yard to be located on the east side of the generator building. Yard will be sized to accommodate a future chiller for the administration building.
 - c. Design of PLC RIO-10 for instrumentation of the proposed 2.0MW Generator as well as monitoring of the O&M Bldg. fire alarm system on the existing WTP #11 SCADA system.

In no event shall any demand for mediation be made after such claim or dispute would be barred by applicable law. The decision of the American Arbitration Association shall be binding on the parties. Mediation fees shall be shared equally.
