

LYING IN THE PLAT OF SUBDIVISION OF S.E. 1/4 OF SECTION 31, TOWNSHIP 44 SOUTH, RANGE 43 EAST, AS RECORDED IN PLAT BOOK 6, PAGE 61, OF THE PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA.

WHEREAS, the Board of County Commissioners of Palm Beach County, Florida (Board), pursuant to authority in Section 336.09, Florida Statutes, and as provided in Palm Beach County Code Chapter 22. Article III, Road Abandonment and Plat Vacation (Ordinance No. 2002-034), known as the Palm Beach County Right-of-Way Abandonment and Plat Vacation Ordinance, and the petition of Palm Beach County (PBC) Department of Airports, PBC Property and Real Estate Management and PBC Parks and Recreation, called a public hearing to be held in the County Commissioners' Chambers, at the Governmental Office Complex, West Palm Beach, Florida, on December 15, 2015, to consider and determine whether or not PBC would vacate, abandon, discontinue and close, renounce and disclaim any right or interest of PBC to the unimproved road right-of-way as shown on the attached Exhibit A; and

WHEREAS, as provided in Palm Beach County Code Chapter 22. Article III, Road Abandonment and Plat Vacation (Ordinance No. 2002-034), notice of the holding of such meeting was duly published in the Palm Beach Post on November 29, 2015; and

WHEREAS, this Board did hold said hearing as advertised and determined that such action will not materially interfere with the PBC Road System and will not deprive any person of a reasonable means of ingress and egress from at least one County, State or Federal highway.
