I. EXECUTIVE BRIEF

**Motion and Title:** Staff recommends motion to approve: Work Authorization No. 4 for the Lift Station Rehabilitation Project (Project) with Hinterland Group, Inc. in the amount of \$1,650,180.05.

**Summary:** On March 10, 2015, the Board of County Commissioners (BCC) approved the Water Utilities Department (WUD) Lift Station Rehabilitation Continuing Construction Contract (Contract) with Hinterland Group, Inc. (R2015-0318). Work Authorization No. 4 provides for the rehabilitation of 10 submersible lift stations located throughout the WUD service area. The rehabilitation work includes replacing pumps, piping, pump guide rails, fences, concrete slabs and driveways to increase reliability, safety, security and ease of maintenance. The Small Business Enterprise (SBE) participation goal established by the SBE Ordinance (R2002-0064) is 15% overall. The Contract provides for SBE participation of 0%, based on a finding by the Office of Small Business Assistance that Hinterland Group, Inc. did not provide specific information in their Schedule 2 SBE document. However, Hinterland Group, Inc. committed to 97.47% SBE participation under the Contract. Work Authorization No. 4 includes 100% SBE overall participation. The cumulative SBE participation including this authorization is 98.84% overall. Hinterland Group, Inc. is a Palm Beach County company. The Project is included in the FY16 Capital Improvement Plan adopted by the BCC. (WUD Project No. 15-079) Districts 2, 5 and 6 (MJ)

**Background and Justification:** WUD owns and operates over 900 wastewater lift stations as part of the wastewater collection system. The WUD's Capital Improvements Plan calls for the rehabilitation of approximately 30 lift stations annually. These upgrades will improve or replace outdated equipment and will increase the reliability during hurricane and other emergency events. Work Authorization No. 4 will result in the rehabilitation of 10 lift stations identified as the next highest combined risk and condition score in a recent assessment of the WUD's lift stations.

#### INTRODUCTION

Palm Beach County (County) entered into an agreement entitled Contract for Lift Station Rehabilitation Continuing Construction Services - Palm Beach County Water Utilities Department Project No. WUD 15-079 (CONTRACT) with Hinterland Group, Inc. (CONTRACTOR) to provide construction services for various general activities on the Lift Station Rehabilitation Continuing Construction Contract dated March 10, 2015, (R2015-0318). This Lift Station Work Authorization will be performed under that CONTRACT.


