AMENDMENT NO. 5 TO AGREEMENT BETWEEN PALM BEACH COUNTY AND NABORS GIBLIN & NICKERSON, P.A. FOR DISCLOSURE COUNSEL AND RELATED LEGAL SERVICES

This Amendment No. 5, dated ______, 2016 amends Agreement R-2010-1221 ("Agreement"), as amended by R-2011-0867, R-2012-1359, R-2013-0854 and R2015-0026, by and between Palm Beach County ("County") and Nabors Giblin & Nickerson, P.A. ("Attorney"), as follows:
