Due to anticipated repairs (tower inspections and replacement) and maintenance (tower cleaning and painting) projects scheduled, \$236,500 is needed to meet the County's requirements through the expiration of this new twelve (12) month renewal term contract. This term contact has one (1) twelve (12) month renewal option remaining. Awardee is located in Palm Beach County. The original bid was established by a competitive selection process. No SBE vendor submitted a bid on this project.
