I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to ratify: Palm Beach County Mayor's signature on the U.S. Department of Justice Office (DOJ), Office of Violence Against Women (OVW), Improving Criminal Justice Responses to Sexual Assault, Domestic Violence, Dating Violence, and Stalking grant application, for the period of October 1, 2016, through September 30, 2019, in a total amount not to exceed \$900,000.

Summary: The grant application was submitted to the Office of Violence Against Women, and is made available by the U.S. Department of Justice. The grant supports efforts to improve a community wide criminal justice response to sexual assault, domestic violence, dating violence, and stalking. The grant will allow the Palm Beach County Sheriff's Office to add two (2) full time law enforcement officer positions to the Domestic Violence Unit to improve efforts to address and reduce sexual assault, domestic violence, dating violence and stalking through increased enforcement and community awareness. The grant positions will be approved for the length of the grant. The emergency signature process was utilized because there was insufficient time to submit this application through the regular agenda process. No County match is required. Countywide (DC)

Background and Justification: The Palm Beach County Sheriff's Office will improve efforts to address and reduce sexual assault, domestic violence, dating violence, and stalking through increased enforcement and community awareness.



PROJECT NARRATIVE

Purpose of Application

Introduction

Domestic violence, dating violence, and stalking (domestic violence related) are pervasive, complex crimes which significantly impact countless men, women, and children in the United States each year. In fact, it is estimated that one in four women in the United States is a victim of domestic violence, dating violence, and/or stalking; one in seven men in the United States is a victim of domestic violence, dating violence, and/or stalking; and approximately 10 million children are exposed to these insidious crimes each year. While these crimes occur across our nation, Palm Beach County has been no exception to this major, devastating epidemic.


Service Area/ Target Population Demographics/Community Description

Palm Beach County, situated along the southeast coastline of Florida, is the largest county in geography east of the Mississippi River, encompassing 1,969 square miles, which includes 45 miles of shoreline, 1,200 square miles of rural, farm land, and 37 independent municipalities. Palm Beach County is the third most populous county in the state with an estimated population of 1.39 million full time residents and over 8 million annual tourist visitors each year. The full time resident population is diverse, including an estimated 76% whites, 18.8% blacks, .6% American Indian/Alaska Native, 2.7% Asians, .1% Native Hawaiian, and 1.7% reporting two or more races. Additionally, 20.7% of the residents are of Hispanic or Latino origin. The age of the population is also diverse with 19.5% of the population under the age of 18 and 22.7% of the population over the age of 65. Female persons make up 51.6% of the total population (2014 U.S. Census).

As described above, Palm Beach County is comprised of both a diverse landscape and diverse population. To this end, we are committed to providing services to our entire community, including those in traditionally underserved populations. As an example, our rural community, referred to as the Glades Region, is a relatively poor farming community whereby the majority of the residents are indigent and live at or below the poverty level. Moreover, this community, located 40 miles west of the remaining County, is diverse in its population whereby Blacks and Hispanics make up the majority at 58% and 28%, respectively. Additionally, 30% of the population speak a language other than English.

Need For Project & Description Of The Problem To Be Addressed

According to the Palm Beach County Sheriff's Office (PBSO), the largest law enforcement agency in Palm Beach County, there were 87,007 calls for service regarding domestic violence related crimes and/or disputes between January 1, 2010 and December 31, 2015. More specific domestic violence related crime information, also provided by the PBSO, is described as follows: In 2013, there were 14,501 domestic violence related calls for service, 3,498 of which involved violence, and 801 of which were disposed as felonies. In 2014, there were 14,296 domestic related calls for service, 3,191 of which involved violence, and 772 of which were disposed as felonies. In 2015, there were 14,803 domestic related calls for service, 3,258 of which involved violence, and 1,185 of which were disposed as felonies. In addition to these alarming rates, there has been a significant increase in the number of domestic related homicides in the past three years wherein 2013 there were 7 domestic related homicides and in both 2014 and 2015 there were 11 domestic related homicides each year.

The number of dating violence and stalking/injunction violation related cases over the past three years is also significant. Specifically, there were 405 dating violence related cases and 512 stalking/injunction violation related cases in 2013. In 2014, there were 501 dating violence related cases and 476 stalking/injunction violation related cases. In 2015, there were 483 dating violence cases and 483 stalking/injunction related cases. Additionally, there were 4,907 no

contact orders/injunctions entered in 2013, 7,735 no contact orders/injunctions entered in 2014, and 7,305 no contact orders/injunctions entered in 2015.

These rates of domestic violence related crimes, domestic violence related murders, and number of no contact orders/injunctions entered in Palm Beach County clearly indicate that domestic violence is a major social crisis in our community. Moreover, in addition to the formidable and rising level of domestic related crimes and homicides each year across Palm Beach County, sections of our community are impacted at a far greater rate than the national average, including the rural Glades Region. This social epidemic requires us to seek a community wide, collaborative, comprehensive strategy whereby offenders are held accountable, victims are supported, and the community is both educated and engaged.

The Impact of Current & Prior Efforts

Palm Beach County has long recognized the extent, seriousness, and significance of domestic violence related crimes in our community. To this end, we have collaboratively addressed this epidemic through several important, meaningful efforts. Numerous coalitions and committees have been created and devoted to finding new and innovative ways to combat domestic violence, including: the Domestic Violence Council, Domestic Violence Working Group, Victim's Rights Coalition, and the Domestic Violence Fatality Review Team. In 1997, PBSO, created a Domestic Violence Unit (DV Unit) solely dedicated to the investigation of domestic violence related crimes and victim advocacy. Also in in 1997, PBSO created a Domestic Assault Response Team(DART) whereby road patrol deputies are specially trained in domestic violence related investigations and likewise facilitate immediate contact between victims and a victim advocate while on the scene. Additionally, PBSO created and maintains the Domestic Abuse Internet Information Network (DAINN) which maintains case information that involves domestic violence related criminal cases enhancing the investigation and prosecution of domestic violence cases by enabling quick access to essential, case related information.

In 1999, Palm Beach County developed a Domestic Violence Court, wherein one judge conducts specialized misdemeanor domestic violence dockets. In 2003, a model court system was implemented and a crossover case docket was developed, dedicated to cases wherein there is

both a criminal and civil domestic violence case involving the same parties. In 2010, members of the criminal justice community, non-profit victim service providers, and community members collaboratively developed the "Palm Beach County Law Enforcement Guidelines for Domestic Violence Investigations" whereby the overarching goals of this unified response are to reduce the prevalence and frequency of domestic violence related crimes in our community, to provide adequate services to victims, and to hold offenders accountable for their crimes.

As a result of these numerous, comprehensive efforts made there have been important improvements and successes realized. As examples, improvements have been made in the areas of pro-arrest policies, increased offender accountability, injunctions for protection, community advocacy for victims and children, an expansion of safe shelters and resources, improved overall access to both legal assistance and service provider interventions, and community education. However, despite these successes, in consideration of the growing population and subsequent growing rate of domestic violence related crimes, additional efforts must be made.

Current Gaps & Barriers

While Palm Beach County has historically demonstrated a commitment to combatting domestic violence related crimes in our community as described above, due to a growing population, related increase in domestic violence related crimes, and continued budget constraints, we have been unable to adequately address this growing epidemic. As an example, and for which we are currently seeking grant funding assistance, the staffing level of dedicated, domestic violence related crimes law enforcement investigators is inadequate to address this growing, community wide conundrum. More specifically, PBSO created the Domestic Violence Unit in 1997, with a complement of one full time supervisor/sergeant, one full time detective, and one full time victim advocate. At the time, Palm Beach County had an estimated population of 863,518 full time residents. Since that time, PBSO's DV Unit has grown to include one additional full time detective and four additional full time victim advocates. However, also since that time, Palm Beach County's estimated population has grown to approximately 1.39 million full time residents, an increase of over 62% since the DV Unit was initially established and staffed. This increase in population and subsequent increase in domestic violence related crimes,

requires additional full time detective staff to adequately and proactively investigate these complex cases.

In another example of current gaps and barriers, with an increase in the number of road patrol deputies assigned to Palm Beach County, a reflection of the growing overall population, there are approximately 190 road patrol deputies who require and have not participated in the specialized Domestic Abuse Response Team training (DART). As described above, DART is a specialized training program focused on domestic violence related cases and facilitation of victim advocacy whereby deputies are more adequately equipped to investigate domestic violence related crimes which increases the likelihood for offender accountability and successful prosecutions. To this end, funding is required to support the costs associated with training these additional, newly hired deputies.

Lastly, while investigation and offender accountability are major cornerstones in the battle against domestic violence related crimes in our community, we also recognize the importance of educating the community and victims regarding domestic violence related crimes, navigating the criminal justice system, obtaining injunctions for protection, accessing victims' services, offender accountability, and overall victim safety. To this end, funds are needed to support these community wide education and outreach efforts. More specifically, our non-profit project partners, the YWCA Harmony House and Coalition for Independent Living Options, Inc., (CILO) are victim centered agencies which provide an array of services to victims of domestic related crimes and related community education. Additionally, CILO provides services and related community education specifically for victims with disabilities. These two, non-profit victim service providers are major community stakeholders, well respected in our community, with access to other major community stakeholders, victims, and community partners. However, due to current budget constraints, essential community wide education and public awareness efforts have been limited.

Florida's STOP Violence Against Women Implementation Plan-Relevance

The proposed project complements the Florida's STOP Violence Against Women Implementation Plan(Florida) in several important ways. Firstly, this project represents a collaborative, community wide effort between law enforcement, non-profit victim service providers, and the criminal justice community. Secondly, this project seeks to increase domestic

violence, dating violence, and stalking arrests, increase coordination, and implement more effective policies, protocols, and services specifically devoted to identifying and responding to violent crimes against women. Lastly, this project seeks to increase the knowledge of providers and allied professionals through the provision of educational training opportunities, and increase specialized training available to members of the criminal justice and social service systems.

Other Grant Funding Opportunities Applied For/Potential Additional Funding Opportunities

Palm Beach County is the current recipient of a 2014 grant through OVW, Palm Beach County's Enhanced Response to Sexual Assault & Domestic Violence. This proposed project will complement and not duplicate the current project. More specifically, the current project focusses on sexual assault response, judicial handling of sexual assault cases, and victim advocacy for victims of sexual assault and victims of domestic violence. This proposed project will conversely focus on the criminal investigation of domestic violence related crimes, comprehensive, community wide education, and the formation of a multi-disciplinary team.

What Will Be Done

Palm Beach County's Domestic Violence, Dating Violence, & Stalking Collaborative Strategy

The Palm Beach County Sheriff's Office (PBSO), the largest law enforcement agency in Palm Beach County, will act as the primary implementing agency in collaboration with two of our long-time, non-profit collaborative partners, the YWCA-Harmony House and Coalition for Independent Living Options, Inc. (CILO) Together, these three partner agencies will facilitate the implementation of all project goals and activities. The project's overarching aim is to reduce the prevalence of domestic violence related crimes in our community, reduce the related catastrophic impact on victims, and increase overall community awareness through education and outreach. To this end, we have identified the following goals: 1) expand the Palm Beach County Sheriff's Office Domestic Violence Unit; 2) train additional law enforcement officers as Domestic Abuse Response Team (DART) specialty officers; 3) increase community awareness through education and outreach efforts; and 4) establish a multi-disciplinary team to foster improved collaborative efforts.

Statutory Purpose Areas & OVW Priority Areas

The project proposal addresses the following Statutory Purpose Areas & OVW Priority Areas, summarized as follows: Statutory Purpose Area 1: Implement pro-arrest programs and policies in police departments, including policies for protection order violations and enforcement of protection orders; Statutory Purpose Area 2: Develop policies, educational programs, protection order registries, data collection systems, and training in police departments to improve tracking cases and classification of complaints involving sexual assault, domestic violence, dating violence, and stalking; OVW Priority Area 1: Strengthen and revitalize coordinated community response and multi- disciplinary teams prioritizing those that meaningfully involve organizations and programs that focus on marginalized communities; and OVW Priority Area 3: Meaningfully increase access to OVW programming for specific underserved populations (based on race, ethnicity, sexual orientation, gender identity, disability, age, etc.).

Project Goals & Objectives

Goal 1: Expand the Palm Beach County Sheriff's Office Domestic Violence Unit

The PBSO Domestic Violence Unit (DV Unit) was created in 1997 to provide a cohesive, holistic, and victim focused approach to special crimes stemming from intra-familial and The Domestic Violence Unit is currently comprised of one (1) interpersonal violence. supervisor/sergeant, two (2) full time detectives, five (5) full time victim advocates, and twentyfour (12) volunteer domestic violence advisors. The Domestic Violence Unit detectives are responsible for the follow-up investigation of reported domestic violence related cases, including but not limited to: domestic related battery, aggravated battery, aggravated assault, kidnapping, false imprisonment, attempted homicide, aggravated stalking, and violations of injunctions for protection. In addition to investigating these domestic violence related crimes, the Domestic Violence Unit detectives also provide in-service training in the areas of specialized domestic violence related case investigations and injunction for protection investigations to all current PBSO deputies, newly hired deputies, and to other local law enforcement agencies. Additionally, the Domestic Violence Unit's victim advocates and volunteer victim advisors provide crisis intervention, ongoing victim advocacy, safety planning, linkage to community resources, assistance in navigating the criminal justice system, assistance with obtaining injunctions for protection, acting as liaison between the victim and law enforcement, and other victim services as needed. All Domestic Violence Unit staff participate in various community committees, task

forces, and networking opportunities whereby critical community partnerships are developed and maintained.

The Palm Beach County Sheriff's Office continues to receive an increasing number of domestic violence related cases each year. In fact, between January 1, 2010 through December 31, 2015, there were 87,007 calls for service regarding domestic violence related crimes and/or disputes. Of these 87,007 calls for service, 21,537 were documented cases of violence and of these 5,614 rose to the level of a felony crime. While the overall community population has grown exponentially since the Domestic Violence Unit was first established in 1997 and likewise the number of domestic violence related crimes have also increased, the staffing of the Domestic Violence Unit has largely remained unchanged. As we effort to promote more proactive, comprehensive, effective investigations of the rising number of domestic violence related crimes, we are seeking funding to expand our Domestic Violence investigative staff.

Objective 1: Hire (2) full time detectives who will be assigned to the Domestic Violence Unit and likewise be responsible for reviewing, investigating, and following up on domestic violence related crime cases throughout Palm Beach County. The grant funded detective positions will provide the following services to Palm Beach County:

- 1) Review reports of domestic violence related cases and protective order violations to ensure that the case has been properly investigated that that pro-arrest policies are being followed. If a deficiency in an investigation is noted, the detective will work with the original responding deputy to correct the deficiency and if necessary assist in gathering the necessary information and/or documentation to support an arrest charge or file charges with the State Attorney's Office.
- 2) Provide on-scene assistance and follow-up investigation for more serious cases, including cases which occur after hours, and ensure that orders of protection are being served and enforced. The detectives will be in contact with the Civil Division of the Palm Beach County Sheriff's Office to facilitate serving of protection orders where the respondent is avoiding service.

- 3) Train road patrol deputies on domestic violence protocols, relevant statutory laws, the PBSO's policies and procedures. The detectives will attend roll-call trainings to discuss new investigation trends, techniques and case laws, and reinforce aggressive enforcement of applicable Florida Statutes.
- 4) Coordinate with DART officers to investigate situations that arise whereby victims, who have in their possession a valid protective order, are reporting suspicious occurrences in and around their residences such as, unexplained damage to property or neighbors reporting sightings of the respondent in the area. Often additional investigation and surveillance is needed to gather sufficient evidence for successful prosecution.
- 5) Update and maintain the secured internet program, ensuring that all evidence is downloaded into the website by PBSO deputies and participating municipalities.

Goal 2: Train Additional Road Patrol Deputies as Domestic Violence Specialty Officers

In 1997, the PBSO implemented a Domestic Abuse Response Team (DART) whereby officers are specially trained and equipped to handle domestic violence related calls. The road patrol deputies are trained by the Domestic Violence Unit staff, including the supervisor/sergeant and detectives. The training is a nine-hour program which includes the dynamics of domestic violence, investigative techniques, collection of evidence, aggressive enforcement of applicable Florida state statutes, enforcement of protection orders, and reinforces the proper utilization of the domestic violence internet program. Currently, PBSO has approximately 1126 DART trained road patrol deputies and approximately 190 road patrol deputies who have not received DART training. It is critical that all road patrol deputies are trained as DART specialty officers as all are subject to responding to domestic violence related calls for service.

Objective 1: Train and equip 190 additional road patrol deputies as DART specialty officers

- The Domestic Violence Unit supervisor/sergeant and assigned detectives will coordinate and facilitate the trainings.
- 2) The trainings will be scheduled over the course of the grant period, at regular intervals, until all remaining road patrol deputies have been trained and equipped as DART specialty officers.
- 3) Once trained, the DART specialty officers will be responsible for responding to all domestic violence related calls within their jurisdiction to determine whether or not a

crime has been committed. To this end, the DART officers will conduct interviews,

obtain search warrants, collect evidence, and identify/apprehend the suspect when there is

probable cause.

4) Once trained, the DART specialty officers will be responsible for determining whether or

not a victim advocate is required to respond directly to the scene, in more severe cases,

and/or facilitate contact between the victim advocate and/or volunteer victim advisor and

the victim.

5) Once trained, the DART specialty officers will be responsible for the timely and accurate

preparation and filing of assigned cases with the Palm Beach County State Attorney's

Office Domestic Violence Elimination Unit (DOVE).

Goal 3: Increase Community Awareness through Education and Outreach Efforts

The Palm Beach County Sheriff's Office, the YWCA Harmony House, and CILO project

partners each recognize that community awareness and education are vital components of our

mission to reduce the incidence of domestic violence related crimes in our community. We also

recognize the importance of targeting specific community members for this awareness and

education, to include: members of the faith based community, medical personnel, and school

staff who play an important role in protecting the safety of victims of domestic violence.

Objective 1: Conduct community presentations and educational sessions throughout the

community

1) Develop and facilitate community wide presentations and educational sessions

regarding the complex domestic violence related crimes including related criminal

justice resources, related victim's resources, and services available. Additionally, we

propose to educate the service provider and faith based community about the signs of

abuse, the cycle of abuse, ways in which one can safely intervene to assist, and

resources available to service providers and victims, including disabled and

underserved victims of domestic violence related crimes. All training conducted will

emphasize victim confidentiality and safety as paramount.

Objective 2: Conduct a public awareness campaign

1) Develop a comprehensive public awareness campaign. This campaign will include public billboard messages to be located throughout Palm Beach County and public transportation billboard messages to be mounted to the side of public transportation busses travelling throughout this region. Public service announcements will be developed and disseminated countywide. Additionally, printed materials will be developed and distributed at community awareness events, local community fairs, and throughout the County as a resource for local service providers and residents. Information to be included on this printed material will be related directly and specifically to domestic violence related crimes, available criminal justice and victim service resources, contact information for project partners, and emergency safety planning tips. Printed materials created through this project could also be utilized in other jurisdictions.

Goal 4: Establish a Multi-Disciplinary Team to Foster Improved Collaborative Efforts

Through this collaborative community approach, we propose to create a multi-disciplinary team to include a diverse group of community stakeholders, including: law enforcement, victim's service providers, social service organizations, members of the faith based community, medical service providers, treatment (substance abuse/mental health) services providers, educational and employment entities, and survivors of domestic abuse related crimes. The multidisciplinary team will develop program strategies, discuss program challenges, problem solve, identify new resources and providers, and ultimately guide Palm Beach County's Collaborative Strategy. Specific and careful attention will be given to the following critical matters: Ensuring the personal safety of victims, ensuring the confidentiality of victim information, ensuring victims have access to services and increasing efforts to review new and active cases to facilitate an increase in arrests and enhancement of prosecutions

Objective 1: Identify multi-disciplinary team members and establish a formal partnership through a Memorandum of Understanding

- 1) Identify and invite multidisciplinary team members
- 2) Develop a formalized memorandum of understanding

Objective 2: Convene multi-disciplinary team on a quarterly basis

- 1) Schedule quarterly meetings
- 2) Facilitate quarterly meetings to include a written agenda, follow up action plans, and meeting minutes

Victim Safety & Autonomy Considerations

All project partners recognize the importance of victim safety and autonomy as essential cornerstones to all project planning and implementation efforts. To this end, the YWCA Harmony House and CILO, both long time victim service providers in Palm Beach County, will provide technical assistance and likewise ensure that all project efforts are developed and implemented accordingly. As examples, through the investigative work of the DV Unit detectives and DART specially trained officers, all victims will be provided information and a direct referral to a victim advocate. An assigned victim advocate will assist the victim in developing a safety plan, accessing services as needed, and in navigating the criminal justice system and civil injunction process. While advocacy will be offered and encouraged, ultimately the victim can exercise his/her right to obtain services and likewise exercise autonomy in all decision making. In another example, through our public awareness campaign and community education/outreach efforts, victim safety, confidentiality, and autonomy will be major themes represented in the information disseminated to the public.

Expected Project Outcomes

As a result of this collaborative approach to combat domestic violence related crimes in our community, we anticipate achieving the following project outcomes: 1) increasing the number of prosecutable domestic violence crime related arrests/cases; 2) increasing offender accountability; 3) increasing victim safety; 4) increasing community awareness; and 5) improving collaboration among key stakeholders and community members.



As Chief Executive Officer of Palm Beach County, I submit this letter to certify to the following:

- 1) The laws or official polices of Palm Beach County encourage or mandate arrests of domestic violence offenders based on probable cause that an offense has been committed;
- The laws or official policies of Palm Beach County encourage or mandate arrests of domestic violence offenders who violate the terms of a valid and outstanding protection order;
- 3) The laws, policies, or practices and the training programs of Palm Beach County discourage dual arrests of offender and victim;
- 4) The laws, policies, or practices of Palm Beach County prohibit issuance of mutual restraining orders of protection except in cases where both parties file a claim and the court makes detailed findings of fact indicating that both parties acted primarily as aggressors and that neither party acted primarily in self-defense;
- 5) The laws, policies, and practices of Palm Beach County do not require, in connection with the prosecution of any misdemeanor or felony domestic violence, dating violence, sexual assault, or stalking offense, or in

connection with the filing, issuance, registration, modification, enforcement, dismissal, or service of a protection order, or a petition for a protection order, to protect a victim of sexual assault, domestic violence, dating violence, or stalking, that the victim bear the costs associated with the filing of criminal charges against the offender, or the costs associated with the filing, issuance, registration, modification, enforcement, dismissal, or service of a warrant, protection order, petition for a protection order, or witness subpoena, whether issued inside or outside the state, tribal, or local jurisdiction; and

- 6) The laws, policies or practices of Palm Beach County ensure that
 - a. No law enforcement officer, prosecuting officer, or other government official shall ask or require an adult, youth, or child victim of a sex offense as defined under federal, tribal, state, territorial, or local law to submit to a polygraph examination or other truth telling devise as a condition for proceeding with the investigation or, trial of, or sentencing for such an offense; and
 - b. The refusal of a victim to submit to an examination described in subparagraph (a) shall not prevent the investigation of, trial of, or sentencing for the offense.

Acknowledgement of Notice of Statutory Requirement to Comply with the Confidentiality and Privacy Provisions of the Violence Against Women Act, as Amended

Under section 40002(b)(2) of the Violence Against Women Act, as amended (42 U.S.C. 13925(b)(2)), grantees and subgrantees with funding from the Office on Violence Against Women (OVW) are required to meet the following terms with regard to nondisclosure of confidential or private information and to document their compliance. By signature on this form, applicants for grants from OVW are acknowledging that that they have notice that, if awarded funds, they will be required to comply with this provision, and will mandate that subgrantees, if any, comply with this provision, and will create and maintain documentation of compliance, such as policies and procedures for release of victim information, and will mandate that subgrantees, if any, will do so as well.

(A) In general

In order to ensure the safety of adult, youth, and child victims of domestic violence, dating violence, sexual assault, or stalking, and their families, grantees and subgrantees under this subchapter shall protect the confidentiality and privacy of persons receiving services.

(B) Nondisclosure

Subject to subparagraphs (C) and (D), grantees and subgrantees shall not-

(i) disclose, reveal, or release any personally identifying information or individual information collected in connection with services requested, utilized, or denied through grantees' and subgrantees' programs, regardless of whether the information has been encoded, encrypted, hashed, or otherwise protected; or

(ii) disclose, reveal, or release individual client information without the informed, written, reasonably time-limited consent of the person (or in the case of an unemancipated minor, the minor and the parent or guardian or in the case of legal incapacity, a court-appointed guardian) about whom information is sought, whether for this program or any other Federal, State, tribal, or territorial grant program, except that consent for release may not be given by the abuser of the minor, incapacitated person, or the abuser of the other parent of the minor.

If a minor or a person with a legally appointed guardian is permitted by law to receive services without the parent's or guardian's consent, the minor or person with a guardian may release information without additional consent.

(C) Release

If release of information described in subparagraph (B) is compelled by statutory or court mandate—

- (i) grantees and subgrantees shall make reasonable attempts to provide notice to victims affected by the disclosure of information; and
- (ii) grantees and subgrantees shall take steps necessary to protect the privacy and safety of the persons affected by the release of the information.

(D) Information sharing

(i) Grantees and subgrantees may share—

- (I) nonpersonally identifying data in the aggregate regarding services to their clients and nonpersonally identifying demographic information in order to comply with Federal, State, tribal, or territorial reporting, evaluation, or data collection requirements;
- (II) court-generated information and law enforcement-generated information contained in secure, governmental registries for protection order enforcement purposes; and
- (III) law enforcement-generated and prosecution-generated information necessary for law enforcement and prosecution purposes.

(ii) In no circumstances may-

- (I) an adult, youth, or child victim of domestic violence, dating violence, sexual assault, or stalking be required to provide a consent to release his or her personally identifying information as a condition of eligibility for the services provided by the grantee or subgrantee;
- (II) any personally identifying information be shared in order to comply with Federal, tribal, or State reporting, evaluation, or data collection requirements, whether for this program or any other Federal, tribal, or State grant program.

(E) Statutorily mandated reports of abuse or neglect

Nothing in this section prohibits a grantee or subgrantee from reporting suspected abuse or neglect, as those terms are defined and specifically mandated by the State or tribe involved.

(F) Oversight

Nothing in this paragraph shall prevent the Attorney General from disclosing grant activities authorized in this Act to the chairman and ranking members of the Committee on the Judiciary of the House of Representatives and the Committee on the Judiciary of the Senate exercising Congressional oversight authority. All disclosures shall protect confidentiality and omit personally identifying information, including location information about individuals.

(G) Confidentiality assessment and assurances

Grantees and subgrantees must document their compliance with the confidentiality and privacy provisions required under this section.

As the duly authorized representative of the applicant, I hereby acknowledge that the applicant has received notice that if awarded funding they will comply with the above statutory requirements. This acknowledgement shall be treated as a material representation of fact upon which the Department of Justice will rely if it determines to award the covered transaction, grant, or cooperative agreement.
