I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to:

A) ratify the signature of the Mayor on the Federally Funded Subgrant Agreement No. 16EA-0F-10-60-01-023, with the State of Florida Department of Economic Opportunity, for the period March 1, 2016, through March 31, 2017, in an amount not to exceed \$3,137,651, for the Low Income Home Energy Assistance Program (LIHEAP);

B) delegate to the County Administrator or her designee, signatory authority on additional exhibits, and any other necessary documents related to LIHEAP requirements; and

C) approve Budget Amendment of \$1,541,624 in the LIHEAP fund to reconcile the budget.

Summary: LIHEAP funds of \$3,137,651 will enable Palm Beach County Community Action Program (CAP) to provide assistance to approximately 7,000 low-income households with energy bills and crisis assistance to prevent service disconnection and to restore utility services. The emergency signature process was utilized because there was insufficient time to submit this application through the regular agenda process. County funds are not required. (Community Action Program) <u>Countywide</u> (HH)

Background and Justification: The LIHEAP Program has been administered by CAP since 1992. The FY 2016–2017 LIHEAP sub grant agreement will continue to ensure that assistance is provided to low-income families to prevent energy service disconnection.
