The County has expended or encumbered \$578,922 (\$79,851/month) during the previous seven and one quarter (7.25) months of the current twelve (12) month term contract. A total increase of \$246,500 (56.69%) over the initial amount of \$527,940, inclusive of the Purchasing Director's ten percent (10%) authority, is necessary due to: the Water Utilities Department's unanticipated repairs due to aging equipment and scheduled maintenance to skid-mounted and portable generators at various County water plants and O&M lift stations (\$204,500); and for Facilities Development & Operations Department's future repairs due to aging equipment at North Region, CJC, Central Region, South Region, Government Center, and West Region (\$42,000). This term contract has four (4) twelve (12) month renewal periods remaining. Awardee is located in Palm Beach County. No SBE vendor submitted a bid on this project.
