I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to Receive and File: termination of an Agreement (R2015-1484) with Jesus and You Outreach Ministries, Inc. (JAY) under the Fiscal Year 2015-2016 Community Development Block Grant (CDBG) Program.

Summary: On October 20, 2015, the Board of County Commissioners (Board) approved an Agreement (R2015-1484) with JAY for \$9,058 under the CDBG Program. Funding was to partially cover costs associated with the operations of an emergency shelter facility which provides services to homeless men. On January 8, 2016, JAY confirmed that it will not accept funding provided under the Agreement due to its inability to implement corrective actions required by Findings and Concerns arising from Department of Economic Sustainability's (DES) monitoring of its Fiscal Year 2014-2015 Agreement (R2014-1473) which provided funding for the same emergency shelter facility. In a letter dated January 15, 2016 to JAY, DES terminated the Agreement for convenience. The entire allocated amount of \$9,058 will revert to the County. These are CDBG grant funds which require no local match. District 7 (JB)

Background and Justification: On July 21, 2015, the Board approved the Fiscal Year 2015-2016 Action Plan (R2015-0939), including CDBG funds of \$9,058 for JAY. On January 15, 2016, the Agreement was terminated for convenience by DES with a ten (10) working days written notice pursuant to the Agreement.

(JAY Ministries) and Palm Beach County. The effective date of termination will be ten (10) working days after receipt of this correspondence by JAY Ministries.

This termination for convenience on the part of Palm Beach County is based on written communication dated January 8, 2016 (attached), whereby JAY Ministries confirmed that it will not be accepting the FY 2015-2016 CDBG funding provided under Agreement R2015-1484 due to its inability to address Findings and Concerns arising from the DES monitoring of the FY 2014-2015 CDBG agreement.

Please note that, to date, JAY Ministries has not submitted any reimbursement requests related to Agreement R2015-1484 and therefore, the entire contract sum of \$9,058 will revert to the County.
