The County has expended or encumbered \$3,689,196 (\$136,637/month) during the previous twenty-seven (27) months of the current thirty-six (36) month term contracts. A total increase of \$1,188,200 over the previously authorized amount of \$4,061,200, inclusive of the Purchasing Director's ten percent (10%) authority, is necessary for the purchase of facilities maintenance supplies during the remaining nine (9) months of the term contracts. The requested increase is due to necessary maintenance and repair projects (WUD \$477,000); addition of necessary items to the contract (Purchasing Warehouse \$420,000); unanticipated purchase of ceiling tiles, welding equipment, air conditioning equipment, and safety supplies (Facilities Management \$105,500); unanticipated repairs at various Fire Rescue stations (Fire Rescue \$75,000); unanticipated replacement and repairs of equipment (Department of Airports \$46,000); necessary first aid and safety equipment (Public Safety \$30,000); unanticipated maintenance for traffic signals and signs (Engineering \$18,000); supplies resulting from increase in case load (Medical Examiner \$8,000); increase for hardware (ISS \$5,700); additional required respiratory safety equipment and first aid supplies (Risk Management \$3,000). This purchase is off the State of Florida Contract #450-000-11-ACS. This term contract has no renewal options. Awardee is located in Palm Beach County. There is no SBE currently certified for this commodity or service.

The County has expended or encumbered \$420,155 (\$80,030/month) during the previous five and one quarter (5.25) months of the current twelve (12) month term contract. Water Utilities Department requests an increase of \$195,855 over the previously authorized amount of \$525,465, inclusive of the Purchasing Director's ten percent (10%) authority, for necessary welding services during the remaining six and three quarter (6.75) months of the term contract. This increased amount is required for welding of aging equipment and structures and for necessary unanticipated repairs. This term contract has four (4) twelve (12) month renewal options. Awardees are located outside Palm Beach County in the cities of Sunrise and Miami, Florida. No SBE vendor submitted a bid on this project.
