AMENDMENT TO MASTER AGREEMENT

This Amendment No. 1 dated ________to the Agreement (R-2013-0889) dated July 16, 2013, by and between Palm Beach County, a political subdivision of the State of Florida, by and through its Board of Commissioners, hereinafter referred to as the COUNTY and AT&T Corp. an entity authorized to do business in the State of Florida, hereinafter referred to as the AT&T Corp.

WITNESSETH

WHEREAS, the parties have entered into an Agreement under which the AT&T Corp. provides certain services to the COUNTY for various projects; and

WHEREAS, the Agreement was previously approved for three (3) years to July 15, 2016 with two (2) - two (2) year extension options; and

WHEREAS, the parties hereto desire to amend the Agreement to extend it for an additional two (2) year period.

NOW, THEREFORE, in consideration of the premises and of the mutual covenants hereinafter set forth and for such other good and valuable consideration, the receipt of which the parties hereto expressly acknowledge, the parties covenant and agree to the following terms and conditions:

- 1. The term of this Agreement as set forth in Article 1.6 is renewed for two (2) additional years to July 15, 2018.
- Except as specifically modified above, the terms and conditions of the
 Agreement is hereby confirmed and remains in full force and effect.

IN WITNESS WHEREOF, the Board of County Commissioners of Palm Beach County, Florida has made and executed this Amendment on behalf of the COUNTY and AT&T Corp. has hereunto set its hand the day and year above written.
