Summary: Palm Beach County was allocated \$144,219 in Federal FY2015 funds and \$164,802 in Federal FY2016 as part of the Edward Byrne Memorial Justice Assistance Grant (JAG) Program for expenditure through FY2018. The JAG Program allows local governments to support a broad range of activities to prevent and control crime based on local needs and conditions. The grants were approved to support the Criminal Justice Commission's existing reentry programs to provide services to reduce recidivism rates in Palm Beach County. These documents have been fully executed on behalf of the Board of County Commissioners (Board) by the Assistant County Administrator in accordance with R2014-1836 and are now being submitted to the Board to receive and file. **No County matching funds are required for this grant**. <u>Countywide (JB)</u>

Background and Justification: The Palm Beach County Criminal Justice Commission Reentry Task Force has developed a Strategic Plan for providing effective and coordinated reentry services to those returning from incarceration. The goal is to reduce the recidivism rate by 50% over 5 years for the target population. The program is intended to reduce recidivism among transitioning offenders as well as reduce future victimization, enhance public safety and improve the lives of communities, victims and offenders. In accordance with County PPM CW-O-051, all delegated contracts/agreements/grants must be submitted by the initiating Department as a Receive and File Agenda Item.




