### I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to approve:** a contract with Scalar Consulting Group, Inc. (SCG), in the amount of \$490,256.67, for professional services for the Benoist Farms Road from S.R. 80 to Belvedere Road project (Project).

**SUMMARY:** Approval of this contract will provide the professional services necessary for the preparation of design plans and construction bid documents for the Project. The Small Business Enterprise (SBE) goal for the Project is 15%. SCG committed to 100% SBE participation between SCG and its four sub-consultants in this contract. SCG has an office in Palm Beach County. SCG is an SBE company.

### Districts 2 and 6 (MRE)

**Background and Justification:** On May 26, 2015, the Consultant's Competitive Negotiations Act Selection Committee selected SCG and, in accordance with PPM No. CW-O-048, the Board of County Commissioners (Board) was notified of the selection on May 26, 2015. Palm Beach County now desires SCG to provide the professional services necessary to prepare the roadway widening and engineering design for the Project. The fee, as detailed in Exhibit "B" of the attached contract, has been negotiated as just and reasonable compensation as follows:

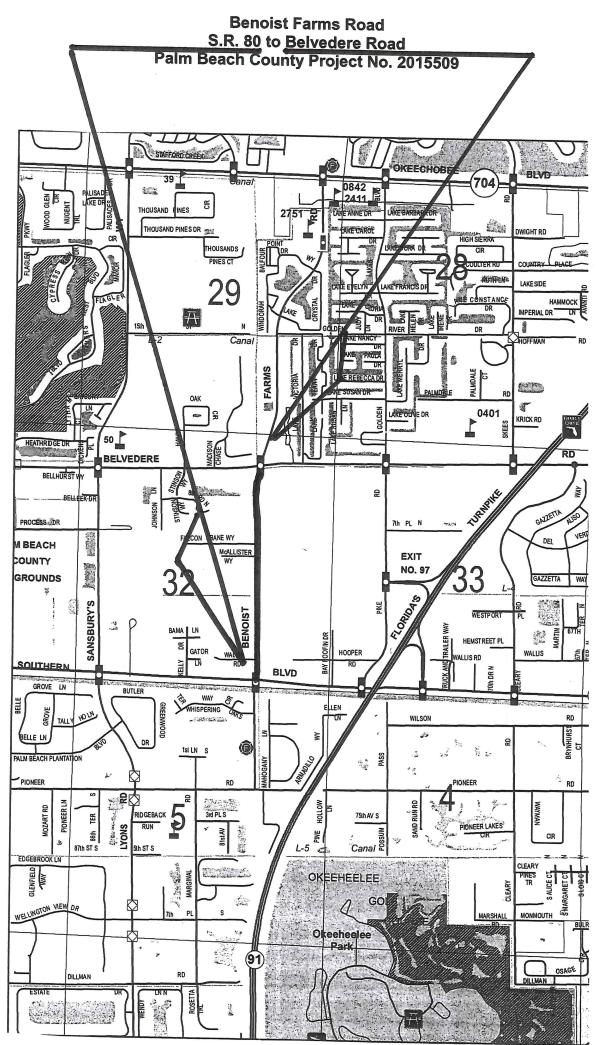
