I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to receive and file:

Summary: In accordance with County PPM CW-O-051, all delegated contracts, agreements and grants must be submitted by the initiating Department as a receive and file agenda item. The attached Second Amendments each dated May 23, 2016, have been fully executed on behalf of the Board of County Commissioners (Board) by the Director, Facilities Development and Operations in accordance to the delegation of authority approved by the Board on June 5, 2012. These executed documents are now being submitted to the Board to receive and file. **(FDO Admin) Districts 1, 6 & 7 (LDC)**

Background and Justification: On June 5, 2012, the Board approved a standard ATM Operating License Agreement with the PBC Credit Union, for the installation and operation of automated teller machines in County-owned buildings, and delegated authority to the Director of Facilities Development and Operations to sign and administer the ATM Operating License Agreement, including all amendments, and extensions thereof. The standard ATM Operating License Agreement sets forth the terms and conditions for the placement, operation, repair and maintenance of the ATM equipment and is subject to an ATM Letter of Agreement between the Tax Collector and Guardians Credit Union f/k/a PBC Credit Union. The Standard ATM Operating License Agreement is for a term of three (3) years with two (2) extensions options for a period of one (1) year each. There is no rent or fee charged to either party.
