I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: a task order to the Annual Civil Contract (R2016-0310) in the amount of \$206,641.45 with Mock, Roos and Associates, Inc. (MRA) for professional services for the 10th Avenue N. and Boutwell Road Intersection Improvements (Project).

Approval of this task order will provide the professional services SUMMARY: necessary for the preparation of design plans and construction bid documents for the Project. The Small Business Enterprise (SBE) goal for the Project is 15%. The SBE participation committed for the Annual Civil Contract by MRA is 100%. MRA has proposed 100% participation for this Project. MRA is a Palm Beach County based company and an SBE company.

District 3 (MRE)

Background and Justification: On March 22, 2016, the Board of County Commissioners (Board) approved an Annual Civil Contract (R2016-0310) with MRA to provide professional services required for countywide projects. Palm Beach County now desires MRA to prepare design plans and construction bid documents for the Project as detailed in "Exhibit A" of the attached task order. The fee, as detailed in Exhibit "B" of the attached task order, has been negotiated as just and reasonable compensation as follows:

Basic Services (Lump Sum)

(Roadway Design Analysis and Plans, Drainage Analysis and Plans, Utilities, Permits, Signing and Pavement Marking Analysis and Signal Analysis and Plans). Reimbursables (Not to Exceed) \$ 47,569.84 (Survey, Geotechnical, Permit Fees. and Reprographics). Optional Services (Not to Exceed) <u>\$7,077.60</u> (Post Design Services). Total: \$206,641.45


