I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve:

- A) Modification No. P00006 (Mod 6) to Other Transaction Agreement HSTS01-13-H-CKP127 (R-2013-0529) (OTA) with the Transportation Security Administration (TSA), for reimbursement of fixed electrical, heating ventilation air conditioning (HVAC), lighting costs and janitorial services for TSA security checkpoint and baggage screening areas at the Palm Beach International Airport (PBIA); and
- B) Modification No. P00007 (Mod 7) to the OTA with the TSA, to de-obligate \$12,176.24 in funding previously obligated by TSA for janitorial services, resulting from the decrease in janitorial space, as provided for in Mod 6.

Summary: The OTA provides for the use of space and cost reimbursement for electrical and janitorial services by the TSA for security checkpoint and baggage screening areas at PBIA. TSA's checked-baggage inspection screening (CBIS) area was relocated in March 2016 as part of the new baggage handling system at PBIA. In the past, electrical costs for TSA's equipment were reimbursed based on a separate meter and the former CBIS area was outdoors with no lighting or HVAC costs. Under Mod 6, electrical costs will be reimbursed at fixed monthly rates of \$2,488.91 for equipment and \$7,261.72 for HVAC and lighting. The new CBIS area is smaller and 11,263 square feet less area is subject to janitorial services; accordingly, the required reimbursement amount will be reduced by \$1,522.03 per month. Mod 7 de-obligates eight months of funding for janitorial services from October 1, 2016, through May 31, 2017, for a total of \$12,176.24. Countywide (AH)

Background and Justification: TSA currently reimburses the County for HVAC, lighting and screening equipment through separate funding that will be discontinued after September 30, 2016. Mod 6 amends the OTA to provide for fixed reimbursement of these charges, which can be adjusted in the future if costs have changed. The electrical charges have been reviewed and are consistent with metered rates and industry standards for the area utilized by TSA. Janitorial services are reimbursed by TSA at \$1.62163 per square foot, being equivalent to the overall cost per-square-foot for janitorial services at PBIA. TSA requires the County to sign Mod 7 to acknowledge this reduction in obligated funding through May 31, 2017. The OTA automatically renews on an annual basis.

B. Recommended Sources of Funds/Summary of Fiscal Impact:

TSA will begin reimbursing for HVAC and lighting at a fixed monthly rate of \$7,261.72. Reimbursement for janitorial services will be reduced by \$1,522.03 per month because of the reduction in space. The calculations above show the net effect of these reimbursements for eight months from October 1, 2016, to the end of the current term on May 31, 2017.

The methodology for reimbursement for electrical for TSA's equipment will change from metered to fixed, but the amount is believed to be equivalent and there is therefore no fiscal impact for this component.

1. Purpose

- a) The purpose of Modification P00006 to Agreement HSTS01-13-H-CKP127 is to:
 - i) Obligate eight months of funding, from October 1, 2016 to May 31, 2017, for TSA electrical, HVAC and lighting costs in the TSA security checkpoint and baggage screening areas at Palm Beach International Airport.
- b) Amend the Agreement and make the following changes as of October 1, 2016:
 - i) TSA Space
 - (1) Exhibit 1A TSA Space, is replaced with Exhibit 1B. (Attachment A)
 - (2) Exhibit 1C TSA Space Summary, is incorporated into the Agreement. (Attachment B)
 - ii) TSA Electrical Costs
 - Exhibit 2M Metered Electrical Costs, is deleted. The separate Miscellaneous Obligation funding for metered electrical costs will be discontinued after September 30, 2016.
 - (2) Exhibit 2A –Electrical Costs for TSA Screening Equipment Power Consumption, is incorporated into the Agreement. (Attachment C)
 - (3) Exhibit 2B –HVAC and Lighting Costs for the TSA Baggage Screening Space is incorporated into the Agreement. (Attachment D)
 - iii) TSA Janitorial Costs
 - (1) Exhibit 4A is replaced with Exhibit 4B (Attachment E)
 - (2) Annual janitorial costs decreased by \$18,264.36 from \$47,773.20 to \$29,508.84 due to a reduction in the janitorial square footage for the TSA baggage screening space.
 - (3) TSA janitorial space decreased by 11,263 sq. ft. from 29,460 sq. ft. to 18,197 sq. ft. The change was due to an Airport renovation which reduced the TSA janitorial baggage screening space from 17,460 sq. ft. to 6,197 sq. ft.

Concourse A/B Security Checkpoint Approximately 6,430 square feet

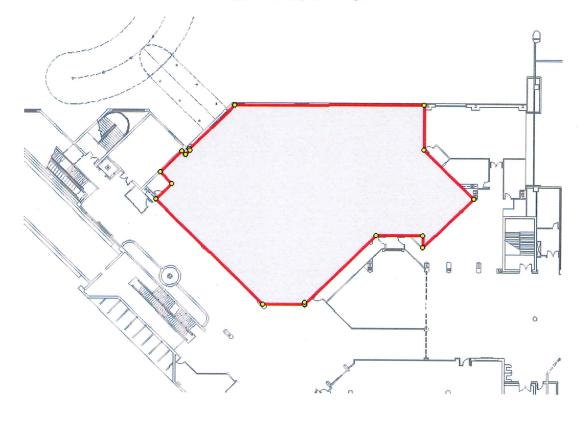
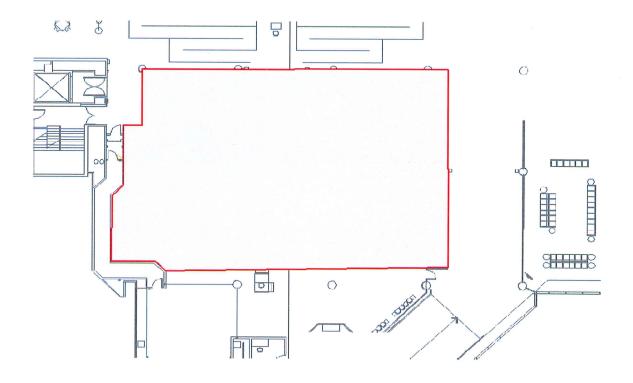

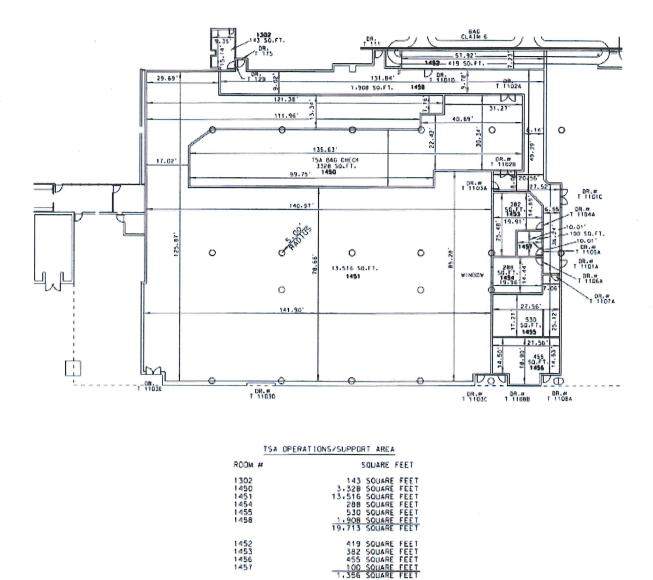
Concourse C Security Checkpoint Approximately 5,570 square feet

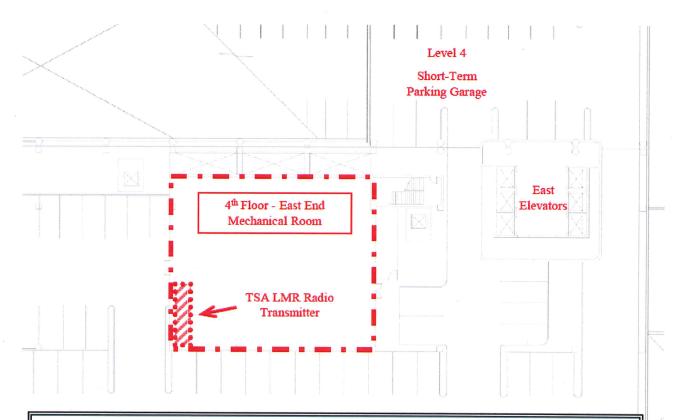

Notwithstanding any other provisions of the Agreement to the contrary, the following provisions control as to the portion of the Space use for the LMR Radio Transmitter:

TSA's use shall be limited to non-exclusive use, and shall be limited to the right to install, operate and maintain radio equipment cabinets and related equipment, and the right to install antennae on the roof of the 4th Floor - East End Mechanical Room.

In accordance with Section VII (C) of the Agreement, County shall have no obligation to provide janitorial and cleaning services and supplies as to that portion of the Space associated with TSA's LMR radio transmitter.

4. Janitorial Cost Reimbursement

As of October 1, 2016, annual janitorial costs for the TSA security checkpoint and baggage screening space will decrease due to a reduction in the TSA janitorial square footage. The annual janitorial cleaning rate will remain the same. (Exhibit 4B)

- TSA janitorial cost reimbursement decreased by \$18,264.36, from \$47,773. 20 to \$29,508.84.
- The pro-rated monthly janitorial cost reimbursement decreased by \$1,522.03, from \$3,981.10 to \$2,459.07.
