I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Contract with Hinterland Group, Inc. (Contract) for the 2016 Telemetry Information Management Systems (TIMS) Upgrade Project (Project) in the amount of \$1,572,132.

Summary: On May 2, 2016, three (3) bids were received to provide and install new Remote Telemetry Units (RTUs) at 50 lift stations and replace electrical panels at 17 stations. The Project is necessary to provide remote monitoring of lift stations to increase wastewater facility productivity and reduce response time in emergency situations. Hinterland Group, Inc. was the lowest responsive and responsible bidder in the amount of \$1,572,132. The Small Business Enterprise (SBE) participation goal established by the SBE Ordinance (R2002-0064) is 15% overall. The Contract provides for SBE participation of 15% overall. Hinterland Group Inc. is a Palm Beach County company. The Project is included in the FY 16-17 Capital Improvement Plan adopted by the BCC. (WUD Project No. 15-072) Districts 2, 3, 5, 6 and 7 (MJ)

Background and Justification: The Water Utilities Department (WUD) currently operates and maintains over 900 lift stations. The WUD Capital Improvements Plan calls for telemetry upgrades of approximately 50 lift stations annually. The Project will install new RTUs with programmable logic controllers, antennas, level transducers, transformers, solar panels, and associated electrical components and instrumentation at 50 lift stations and replace electrical panels at 17 stations in order to meet the latest WUD standards. The TIMS allows remote monitoring of many of these lift stations from a central location utilizing an integrated radio telemetry and plant process control computer network. The Project will facilitate operating the wastewater facilities at minimum cost while at the same time minimizing response time to emergency situations.



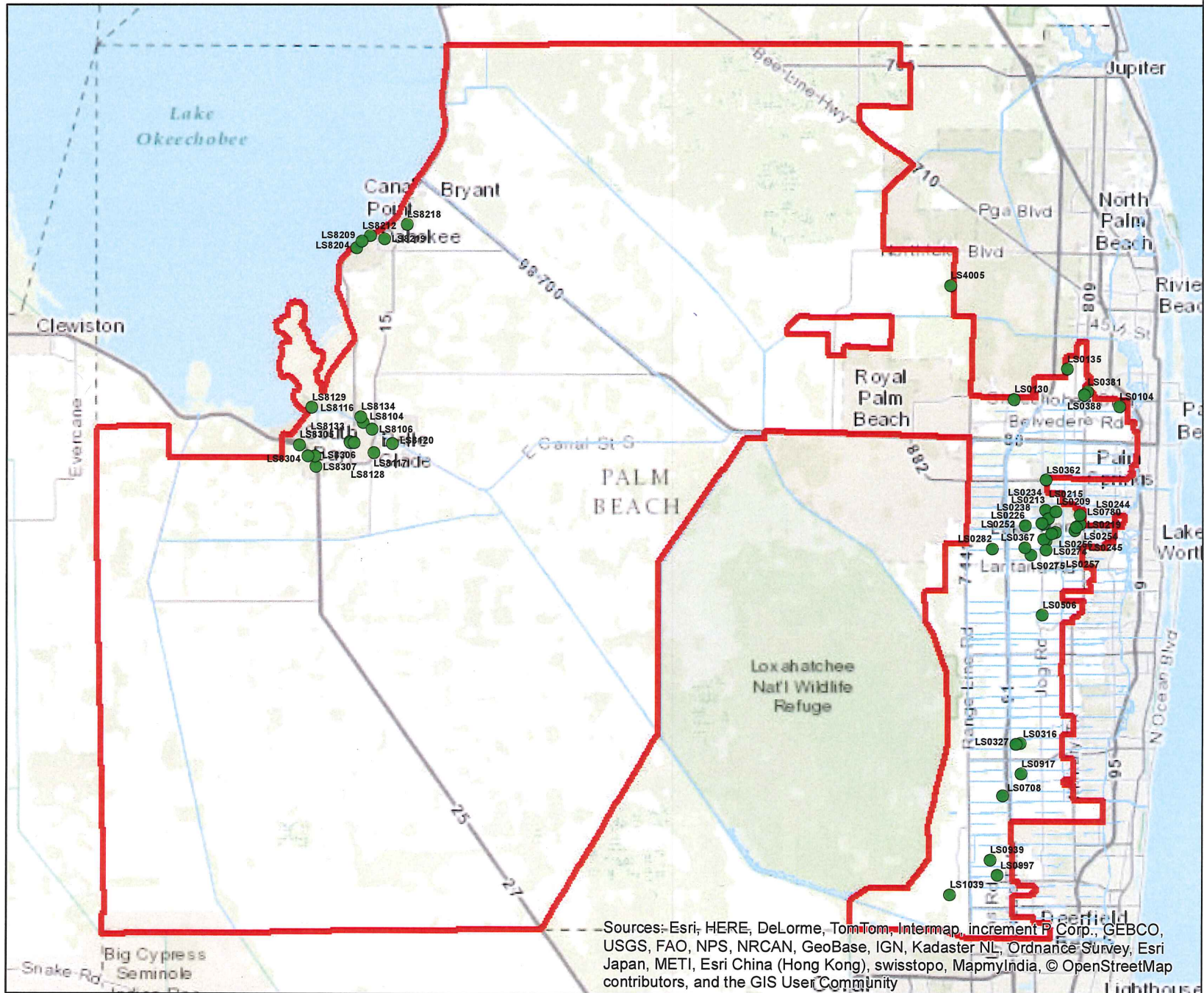

The bid opening for the above referenced project was held on Thursday, May 2, 2016. Proposals were received from three (3) contractors. The complete Bid Tabulation is attached. The Engineer's opinion of probable construction cost was \$2,095,448.00. The low bidder is Hinterland Group, Inc. with a construction cost of \$1,572,132.00 for the bid.

An evaluation of the low bid by Hinterland Group, Inc. is as follows:

1. The first low bidder, Hinterland Group, Inc., provided properly executed Bid Forms in the Contract Documents.
2. Bid security equal to 5% of the total base bid was enclosed with the bid.
3. SBE-M/WBE Schedules #1 and #2 were properly filled out. Hinterland Group, Inc. has met the 15% SBE goal established under the SBE Ordinance. The Compliance Review completed by the Office of Small Business Assistance states that Hinterland Group, Inc. has met the SBE goal with 15% SBE participation for this project (See attached review letter from Patricia Wilhelm dated May 18, 2016.).
4. The County Attorney (CAO) has reviewed the bid and Bid Review Comments for the three (3) lowest bids. For Hinterland Group, Inc., no major irregularities were identified. (See attached Bid Review Comments and email from CAO's Michael Jones dated May 19, 2016.).
5. There was one addendum issued for this project. Hinterland Group, Inc. acknowledged the addendum.

6. Hinterland Group, Inc. holds valid general contractor and occupational licenses. Hinterland Group, Inc. had a valid Palm Beach County business tax receipt at the time of the bid submittal (See attached Palm Beach County Tax Collector receipt.).
7. The first low bidder, Hinterland Group, Inc., holds a principal place of business in Palm Beach County. The contractor holds a valid state contractor's license (See attached license information.).

Contract award is recommended to the lowest responsive bidder, Hinterland Group, Inc., in the amount not to exceed \$1,572,132.00 for the bid, subject to formal approval by the PBC Board of County Commissioners. A copy of this notice has been emailed to all bidders and posted at the bid opening location and will be left there for a minimum of five (5) business days.

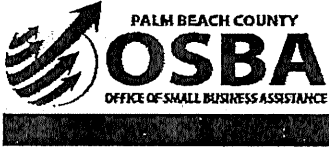

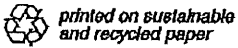

The three (3) bids received for the TIMS 2016 project has been reviewed. The errors, omissions or irregularities found in the bid are noted below.

Hinterland Group, Inc.

1. No errors, omissions or irregularities found

Electron Corporation of South Florida

2. Errors in bid tabulation.

Energy Efficient Electric, Inc.

1. Has Business/Contractor submitted a valid business tax receipt with bid? The tax collector website indicates that taxes are paid to date; but the receipt submitted with bid is expired. A City of West Palm Beach tax receipt was also submitted and is current.
2. Subcontractor Engineer Service Corporation's certification with Palm Beach County is active but the insurance portion expired on 11/15/15.
3. Subcontractor Engineer Services Corporation is not listed in Tax Collector's business tax database.

Thanks. Given that no irregularities are identified for the low bidder, Hinterland Group, Inc., there is no issue on my end with WUD recommending an award to them. For purposes of ranking/posting, my comments on the irregularities of the second and third low bidder as found on the Bid Review Comments document are as follows:

Electron Corporation: The errors in the extension of the unit prices was properly corrected in accordance with Section 5.1.3 of the Instructions to Bidders (ITB). This is not an irregularity that would require the disqualification of Electron, it just requires that the price be modified.

Energy Efficient Electric:

1. To the extent that it has been verified that they do have a current valid BTR, the failure to provide a copy of the current certificate is a minor irregularity and waiveable.
2. Insurance requirements are not required to be met at the time of bidding, but instead prior to the execution of the contract per Section 5.2.5 of the ITB, so this is not an irregularity.
3. Per Section 2.2 of the ITB, a valid PBC BTR is required at the time of bid submission, so, unless they are exempt under section 205.065, this would be an irregularity. If they were the low bidder I would recommend asking whether the exemption applies; I'm not sure how the department normally handles such a situation when this concerns the third place bidder.

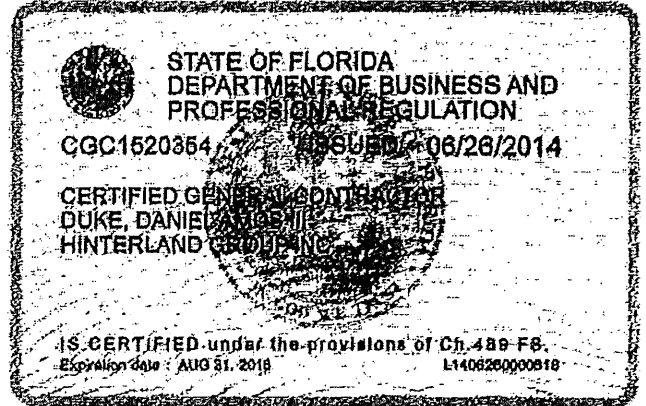
