I. EXECUTIVE BRIEF

Motion and Title: **Staff recommends motion to approve**: Consultant Services Authorization (CSA) No. 20 with Colome & Associates, Inc. (R-2014-1916) to provide architectural/engineering services for the Water Utilities Department Water Treatment Plant (WUD WTP) No. 11 Membrane Building Addition/Renovations and New Storage Building (project) in the amount of \$151,062.

Summary: The WUD WTP No. 11 (WUD Project No. WUD 16-089) project consists of design, permitting and construction administration for an addition to the Membrane Building of approximately 2,300 square feet consisting of new offices, a conference room, break room, women's and men's locker rooms and interior renovations to the existing spaces as well as a separate 2,400 square foot storage building. The construction cost estimate for the project is \$1,900,000. Colome & Associates, Inc. is a Palm Beach County business and will be using all Palm Beach County sub-consultants. This contract includes Small Business Enterprise (SBE) goal of 99%. SBE participation under this CSA is 100%. Funding for this work is from the Water Utilities Department Capital Improvement Fund. (Capital Improvements Division)

Background and Justification: The WUD WTP No.11 existing membrane building and the new storage building will be located on the western portion of the development site in Belle Glade and were originally approved on November 18, 2005, as part of a Final Development Review Officer (FDRO) approval (BA #2005-462). The development was further refined in 2015 when WUD amended the Final Site Plan to reconfigure the building and operations layout. PBC Zoning Division granted FDRO Final Site Plan approval on June 10, 2015.

Design and construction of the membrane processing building addition and interior renovations are needed to provide additional space for personnel necessary to operate WTP No. 11. A new storage building will also be designed and constructed to provide much needed space for storage of material and parts currently non-existent.



Our Firm – Colome' & Associates, Inc. (Architect) – would like to thank you for the opportunity to provide Palm Beach County Facilities Development & Operations Department with this proposal for professional services for the WPT#11 Membrane building addition and an new air conditioned storage building at the existing WROC site located in Belle Glade, Florida.

The scope of work includes the following professional services; architectural, surveying services, geotechnical engineering, civil engineering, structural engineering and M.E.P. engineering, design, construction documents, bidding documents and construction administration services for the work described above and the architectural and M.E.P. conceptual design narratives and documents prepared by our office and dated April 28, 2016.

The project will consist of a new one-story building addition of 2,800 square feet to the existing WPT#11 Membrane building, interior renovations of 512 square feet and a new one-story air conditioned storage building of 2,400 square feet. The proposed building addition consist of men's and women's locker rooms, conference room, offices, lunch room, copy room, storage room, lobby space expansion, janitor's closet, and mechanical and electrical rooms. The proposed interior renovations consist of a new office and storage room in existing foyer 100, reconfiguration of existing office 105, and a new door in existing lab 101. The proposed air conditioned storage building consists of open storage areas, office, restroom, and mechanical room. The proposed membrane building addition and existing spaces, including the proposed new storage building will be on a new chilled water mechanical system. The proposed additions will have lighting modifications, new identification room signage throughout renovated and new areas, reconfiguration of existing mechanical ductwork, modifications to existing fire sprinkler system, modifications to existing and new intrusion alarm, modifications to existing and new card access, modifications to existing and new CCTV for building, and replacement of existing fire alarm system at renovated area and provide new system at proposed storage building.

Exterior renovations consist of providing new parking stalls at the existing northeast corner of the existing parking area, chiller yard, new driveway curb cuts for the proposed storage building, and coordination of underground utilities.

electrical and data requirements with PBC furniture vendor is included within this fee
proposal. Interior and exterior furnishing shall be selected and purchased by Palm Beach
County.

• Preparation and Permitting Submissions

Prepare and submit documents for permitting to the Palm Beach County Building
Department, Palm Beach County Health Department – Potable Water Main Construction
and South Florida Water Management District – Minor Permit Modification.

Bidding

 Assist Palm Beach County in preparation of addenda and respond to General Contractor's RFI's during Bidding process.

Construction Administration

- Make a minimum of one visit per week by the architect, engineer, or subconsultants to
 the site to observe the progress and quality of the executed work and to determine in
 general if the work is proceeding in accordance with the Contract Documents. The
 Architect / Engineer shall not be required to make exhaustive or continuous on-site
 inspections to check the quality of work, nor shall the Architect be responsible for the
