Summary: The Parks and Recreation Department operation (RRL) from 2008 to 2015 and has transferred operation of Service. The Park Improvement Fund has \$3,670 left from 1000 fro	of the program to the (Cooperative Extension

and staff is requesting approval to transfer these funds to the Cooperative Extension Service to continue funding the program. Countywide (AH) Background and Justification: In 2008, the Parks and Recreation Department was contacted by

the Weinig Foundation to start a Read a Recipe for Literacy Program (RRL) for children at the Westgate and West Jupiter Recreation Centers. RRL was founded in 2007 under the auspices of the Weinig Foundation. Established in 1995, this fully-accredited 501 c (3) organization promotes education and literacy in innovative and engaging ways. RRL works to strengthen the community by empowering its members with better communication skills and use recipes - literal and figurative ones - to build literacy. RRL primarily emphasizes the importance of communication, literacy, and the community. RRL was run at Westgate and West Jupiter between 2008 and 2012 through generous donations from the Weinig Foundation totaling \$23,000. In 2015, the Parks and Recreation Department and the Weinig Foundation agreed that the program could better serve the community operated by the Cooperative Extension Service. The Parks and Recreation Department is now requesting approval to transfer the remaining program funds of \$3,670 to the Cooperative Extension Service so that they may establish budget for this program.
