#### I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to:

**A) Receive and File** the electronically executed Federal Transit Administration (FTA) Application FL-2016-035-00 for \$6,637,601 (R2016-0821), and

**B)** Approve a Budget Amendment of \$6,637,601 in Palm Tran's Grants Fund 1341 to recognize the grant award.

**Summary:** On June 21, 2016, the application for Section 5339 funds for \$6,637,601 was approved by the Board of County Commissioners (BCC) (R2016-0821). The application requested funds for planning, engineering, permitting and a portion of the construction for the expansion of Palm Tran's South County administrative and maintenance facility. The document has been fully executed on behalf of the BCC by the Palm Tran Director of Support Services through the County Administrator in accordance with R2016-0821, which delegated authority to execute, on behalf of the BCC, and to transmit electronically the BCC's approval of the grant application, award and resulting grant agreement. In accordance with County PPM CW-0-051, all delegated contracts/agreements/grants must be submitted by the initiating Department as a Receive and File agenda item. The executed document is now being submitted to the BCC to allow the Clerk's Office to receive and file it. <u>Countywide</u> (DR)

**Background and Justification:** Execution of the FTA award represents the County's legal affirmation to abide by FTA and other federal requirements as described in the Master Agreement FTA MA (22) dated October 1, 2015 and approved by the BCC on June 7, 2016 (R2016-0716). All grant documentation was submitted and executed through the Transit Award Management System (TrAMS), FTA's platform to award and manage federal grants.

#### **Project Description**

Palm Tran is expanding the South County (SC) facility located at 100 N Congress Ave, Delray Beach, FL 33445; to accommodate Palm Tran's growth. Both North and South County facilities are operating beyond capacity. On November 5, 2013, Palm Beach County acquired land adjacent to the SC facility; on March 1, 2016 the contract for architectural and engineering services for the SC expansion was awarded to Colome and Associates Inc., a DBE Company.

The grant will fund the architectural and engineering services for the design, permitting, and construction phase services for expansion and renovation of the Palm Tran South County Facility which includes: addition of approximately 28,000 square feet of building space consisting of offices, locker rooms, training center for bus operators and ancillary support space, addition of a new 135 vehicle parking lot for employees on the south side, and addition of a bus lift at the existing maintenance building. This grant will cover the cost of design and construction; future grants will cover the cost of the equipment.

Palm Beach County will use other grants in the funding of this project:

FL-90-X812 - The grant will be amended to include \$1,131,316 for construction, the funds were obligated for land acquisition for the North County Facility, Palm Beach County will concentrate available funds on the South County expansion.

FL-90-X881 – The grant includes \$3,022,844 for the South County expansion. Palm Beach County anticipates to include additional funding in the FY2017-5307 grant application to complete the construction.

#### **Project Benefits**

The 2011-2021 Transit Development Plan (TDP) and includes over 100 individual improvements to the fixed route system. In total, the plan calls for the addition of upwards of 60 buses, 105 bus operators, 30 mechanics and an additional 20 administrative staff members. The planning process for these improvements has identified numerous deficiencies at the West Palm Beach and Delray Beach facilities that would prevent growth. These include but are not limited to, insufficient parking for buses and employees, limited expansion possibilities for the existing administrative offices and maintenance garage as well as a need to expand cash-counting facilities. The most significant issue at the South County Facility is the lack of available parking for additional buses. Specifically, Palm Tran cannot expand beyond an additional 5 buses total. Without additional land to support expansion, it will be impossible for Palm Tran to effectively enhance its fixed route service.

The expansion of the South County Facility benefits all residents in Palm Beach County. The service needs to be expanded to accommodate population growth. Palm Tran needs adequate facilities to accommodate all the necessary changes to the fixed route service.

In addition to the opportunity to increase the number of parking spaces for both employees and buses, the construction will expand the administration building on the existing South County Facility site to accommodate additional drivers and staff required for the increase in service. This project will include a building expansion to house additional administrative employees and the expansion of dispatch and drivers rooms. The southeast bay of the maintenance garage is currently used to service supervisor/relief vehicles and houses a car lift for this purpose. A new car-only bay will be constructed to free up the existing bay for bus service.

#### Additional Information

Palm Tran, Inc. provides public transit service in Palm Beach County, Florida. Palm Tran is an agency of the Palm Beach County Board of County Commissioners. Palm Tran has several "facilities" located throughout Palm Beach County that include administrative services; bus, relief vehicle and employee parking; and maintenance operations. One such existing facility is located at 100 North Congress Avenue within the municipal limits of the City of Delray Beach, Florida (This is the facility referred in this application as the "South County Facility").
