I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Amendment No. 1 to the contract with The Weitz Company, LLC (R-2016-0763) in the amount of \$346,395 for the North County Government Center Hearing Room #2706 and Secured Corridors project in Palm Beach Gardens establishing a Guaranteed Maximum Price (GMP).

Summary: This Amendment authorizes conversion of Hearing Room 2706 to a courtroom and providing improvements to the judicial corridors which will be converted from public access to secured access only. This Amendment is necessary due to an increase in demand for courtrooms, to segregate the Judge's work areas from the public, and to enhance security for the Judges. The duration of construction is 99 days. The Small Business Enterprise (SBE) goal for this contract is 15%. The Weitz Company, LLC's SBE participation for this Amendment is 36.2%. This project was fully funded from the Public Building Improvement Fund in FY16. The Weitz Company, LLC is a Palm Beach County business and it is anticipated that 85% of the work will be performed by Palm Beach County contractors. (Capital Improvements Division) District 1 (LDC)

Background and Justification: Amendment No. 1 establishes a GMP of \$346,395 and 99 calendar days for completion. The GMP includes the cost of work, the construction manager's fee and a contingency. Construction Manager (CM) at Risk is a project delivery method in which the CM provides design phase assistance, evaluation of cost, schedule and implications of alternate designs, systems and materials, and serves as general contractors issuing the subcontracts for construction.



AMENDMENT NO. 1 TOCONTRACT FOR CONSTRUCTION MANAGEMENT SERVICES NORTH COUNTY GOVERNMENT CENTER HEARING ROOM 2706 & SECURED CORRIDORS PROJECT NO. 16206

WHEREAS, the Owner and Construction Manager (**The Weitz Company, LLC**) acknowledge and agree that the Contract between Owner and Construction Manager dated 06/21/16 (R-2016-0763) is in full force and effect and that this merely supplements said Contract;

WHEREAS, the parties hereto entered into a Contract between Owner and Construction Manager whereby the Construction Manager has rendered or will render pre-construction services as specified therein; and

WHEREAS, the parties have negotiated a Guaranteed Maximum Price, including Construction Managers fees for construction and warranty services and other services as set forth herein and in the Contract;

WHEREAS, the Construction Manager represents that the Construction Manager, Subcontractors, material and equipment suppliers have compared Phasing, Demolition, Architectural, Structural, Mechanical, Electrical, Plumbing, Civil and Site Drawings and Specifications and have compared and reviewed all general and specific details on the Drawings and that all conflicts, discrepancies, errors and omissions, which are within the commonly accepted knowledge based of a licensed general contractor, subcontractor, trades persons, manufacturers or other parties required to carry out the Work involved in this Amendment, have been corrected or clarified prior to execution of this GMP Amendment to the Contract, and therefore Construction Manager warrants that the GMP (exclusive of contingency) includes the cost of correcting all conflicts, discrepancies, errors, or omissions which Construction Manager identifies, or should have identified through the exercise of reasonable skill and care, during the preconstruction phase of this Contract.

WHEREAS, the Construction Manager's review and comparison of all Drawings has taken into consideration the total and complete functioning of all systems and therefore the Construction Manager represents that the GMP represents the total cost for complete and functional systems.

NOW THEREFORE, in exchange for the mutual covenants and promises set forth herein and the sums of money agreed to be paid by the Owner to the Construction Manager, the parties agree as follows:

(1) GUARANTEED MAXIMUM PRICE

Pursuant to Article 2.2 and Article 6 of the Contract between Owner and Construction Manager, the parties have agreed to the establishment of a Guaranteed Maximum Price of \$346,395 for the construction costs of North County Courthouse Hearing Room 2706 and Secured Corridors. Refer to Exhibit A.

(2) SCHEDULE OF TIME FOR COMPLETION

Pursuant to Article 5.3, Construction Manager shall substantially complete the project within **99 calendar days** of receiving the Notice to Proceed with construction work from the Owner. Liquidated Damages are **\$500.00**/day for failure to complete within the contract time or approved extension thereof.

GMP Proposal

The Weitz GMP estimate is based on 100% construction documents and specifications dates July 21, 2016 by Leo A. Daly. The scope of work is included as noted below with specific assumptions and clarifications attached.

Division 01 - General Requirements

- 1. General conditions are included for 11 weeks of construction including temporary construction facilities and site operations.
- 2. The project is anticipated to be constructed from approximately Mid December of 2016 through the beginning of March of 2017. A preliminary construction schedule is attached pending receipt of permit and NTP. This schedule is based on an early release of shop drawings for critical trades prior to the end of October.
- 3. Permit Fees are excluded and are "By Owner" except for application fee already paid by Weitz.
- 4. General Liability Insurance and bond is included.
- 5. A Contractor Contingency is included at 5% of the overall budget.
- 6. The CM Fee will be equitably adjusted for work adds to the original scope after the scheduled substantial completion date.
- 7. BIM Coordination and/or 3D Modeling is not included.
- 8. Overtime/night shift premium is not included.

Division 02 - Demolition/Abatement

- Demolition tasks will be scheduled for daytime operations. Effort will be exerted to minimize disruption to ongoing facilities operations. Demolition tasks may require restricting vehicular and/or pedestrian access. Effort will be exerted to minimize disruption to public access and parking.
- 2. No Abatement is included.

Division 06 - Wood, Plastics & Composites

- 1. Hardboard Sheeting will be set on the existing floor during the transportation of material in and out of the work areas and removed from common areas when not in use on a daily basis.
- 2. Clear plastic sheeting will be taped to wall so as to minimize contamination from dust, fingerprints, smudges, scratches etc. and removed from common areas when not in use on a daily basis.
- 3. Maple veneer wall panels with black stained laminate reveals to match as closely as possible to the existing adjacent courtrooms.
- 4. Black stained laminate bases to match as closely as possible to the existing adjacent courtrooms.
- 5. Mock Up as indicated on AE104 is not included.
- 6. Bullet proof mesh, countertops, millwork are included as indicated in the contract documents.

Division 07 – Fireproofing & Firestopping

1. Seal all penetrations in Fire Rated Walls made during the construction process 3M Brand Fire Barrier Caulking

Division 08 – Doors, Frames & Hardware

- 1. Existing 2721 door and frame will be relocated. New door and frame will not be provided.
- 2. Hardware for door 1404 has been included as hardware group No. 02, not 03 as in the specifications.
- 3. All doors with electronic mortise locks will be tied into the fire alarm.
- 4. Card access is not indicated at door 2707 thus is not included (see detail 5 on sheet E202 regarding note to add card access).

Division 09 – Finishes

- All disturbed Drywall to be repaired and/or repaired to match existing finishes.
- Granite Verde Selva is excluded as it is not currently available and the following allowances Wall tile at \$10.00 per square foot plus tax and delivery Slab at \$1,728.00 for Countertop and Cap
- have been included in the GMP.
- 3. Carpet to the existing Judge's Bench, Clerk's Station and Access Ramp is included to match closely as possible to the existing.
- 4. Repainting of existing walls to match as closely as possible to the existing.
