#### I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to approve:** Consultant Services Authorization (CSA) No. 25 for Southern Region Water Reclamation Facility (SRWRF) Electrical Master Plan Project (Project) with Smith Engineering Consultants, Inc. in the amount of \$179,694.96.

**Summary:** On June 3, 2014, the Board of County Commissioners (BCC) approved the Water Utilities Department (WUD) Engineering/Professional Services Contract (Contract) with Smith Engineering Consultants, Inc. (R2014-0828). CSA No. 25 provides for a comprehensive electrical master plan study for the SRWRF. The SRWRF is 25 years old and is nearing the renewal cycle for major electrical equipment and electrical cabling. The Project is necessary to maintain the SRWRF at peak performance, improve safety, and is part of the WUD asset management plan. The Project will assess the condition of the electrical equipment and cables and determine the need for future capital improvements and necessary funding requirements. The Small Business Enterprise (SBE) participation goal established by the SBE Ordinance (R2002-0064) is 15% overall. The Contract provides for SBE participation of 100%. CSA No. 25 includes 100% overall participation. The cumulative SBE participation is 100% overall. Smith Engineering Consultants, Inc. is a Palm Beach County company. The Project is included in the FY17 Capital Improvement Plan adopted by the BCC. (WUD Project No. 16-050) <u>District 5</u> (MJ)

**Background and Justification:** The SRWRF is 25 years old and will soon require major electrical renewal and upgrades to maintain peak performance. The SRWRF uses a 4,160-volt distribution system to the 12 buildings, where the power is subsequently reduced with transformers to 480-volt. The transformers are nearing the end of their useful life. Arc flash studies have recommended installing electrical current limiting devices to increase safety.



## **CONSULTANT SERVICES AUTHORIZATION NO. 25**

#### PALM BEACH COUNTY WATER UTILITIES DEPARTMENT ENGINEERING/PROFESSIONAL SERVICES

#### SCOPE OF WORK FOR SRWRF Electrical Master Plan

#### INTRODUCTION

Palm Beach County (COUNTY) entered into an agreement entitled Contract for Engineering/ Professional Services - Palm Beach County Utilities Department Project No. WUD14-006 (CONTRACT) with Smith Engineering Consultants, Inc. (CONSULTANT) to provide engineering services for various general activities (Reference Document <u>R2014-0828</u>). This Consultant Service Authorization will be performed under that CONTRACT.

#### SCOPE OF SERVICES

## Task 1 - Condition Assessment (Electrical Equipment and Cables):

- 1. The CONSULTANT will visit the site and structures to examine the existing electrical and instrumentation equipment types, age, and condition. (No testing of equipment or cables will be performed under this scope of services; however review of available electrical test results performed by others on behalf of WUD will be reviewed to assist with the condition assessment.)
- 2. Prepare updated record drawings identifying the main electrical assets throughout the facility and indicating their locations on site.
- 3. The CONSULTANT will evaluate the present age and condition of the existing electrical and instrumentation systems and equipment and offer our recommended improvements.
- 4. Prepare preventative maintenance schedules and scopes of work for each of the main asset categories and type of equipment on site.
- 5. Prepare a reserve study outlining the necessary budget and schedule for maintenance, repair, and replacement of the main electrical assets considering the existing age and expected service life of the equipment.
- 6. The CONSULTANT will issue a draft of the reserve study for review by WUD. The CONSULTANT will attend a review meeting with WUD and incorporate comments from review meeting into the final reserve study.

#### Task 2 - Electrical Specifications:

1. Update the PBD WUD standard electrical specifications in accordance with the latest industry standards and codes, and in accordance with WUD staff design criteria. The CONSULTANT will also make recommendations for revisions to the specifications in accordance with our own engineering and design experience.

#### Task 3 - Plant Fiber and PLC Recommendations:

 Evaluate the existing plant control system and associated communication network including the following: overall system architecture, communications protocol, network hardware and wiring, and software. The information to be used for this evaluation will be provided under a separate CSA (Instrumentation Loop Diagrams). The CONSULTANT will make recommendations for improvements throughout the network and provided estimated costs for the same.

#### Task 4 - Electrical Master Plan:

- 1. Evaluate the existing electrical and instrumentation systems and equipment in accordance with the proposed future improvements throughout the plant. These improvements are proposed in up to three (3) consecutive phases with separate improvements to be made in each phase. Most of the improvements are listed in the "Summary of Improvements" table at the end of the draft report prepared by Hazen and Sawyer dated June 15, 2016.
- 2. The CONSULTANT will prepare a recommended plan for improvements to the existing electrical and instrumentation systems and equipment in accordance with the proposed future improvements throughout the plant. The CONSULTANT will recommend electrical system improvements in phases to coincide with the phasing of the proposed plant improvements. Consideration will be given within each phase to later phases so that the recommended improvements to the electrical systems will carry through to future phases. (No re-work of the electrical system improvements made in an earlier phase should be required for later phases.) The CONSULTANT will also advise on the sizing of key electrical equipment, such as step-down transformers, switchgear, conduit and conductors, and relative spare capacity of this equipment and the cost benefit of upsizing key electrical equipment to gain additional capacity.
- 3. The CONSULTANT will provide options as available within each phase for the proposed electrical systems improvements along with estimated costs for these improvement options. Cost estimates will be Class 4 in accordance with the Association for the Advancement of Cost Estimators (AACE) Internal Recommended Practice No.18R-97.
- 4. Prepare five (5) copies of the draft electrical master plan detailing findings, observations and recommendations from Tasks 2, 3 and 5 for review and comment, attend a review meeting to discuss the draft, and prepare and present a PowerPoint presentation of the draft report.
- Make final corrections to the electrical master plan and deliver five (5) copies and one (1) PDF to the Owner. Prepare and present a PowerPoint presentation of the executive summary of the final report.

The COUNTY will provide all available record drawings in AutoCAD format and O&M manuals of the facility to the CONSULTANT. The COUNTY will also provide all other available information pertaining to the plant electrical system including equipment and cable test reports, FPL records, etc. The COUNTY will provide a site plan and a list of the proposed electrical loads for each of the three (3) phases. The COUNTY will provide the assistance of a plant electrician to accompany CONSULTANT staff during their site investigations (approximately 2 months total time). The plant electrician will locate and identify the existing electrical systems

and equipment, including power, controls, and instrumentation, and open manholes, hand holes, and pull boxes as necessary to observe the existing underground wire and cables. The electrician will also open electrical equipment enclosures as necessary to observe the interiors of the equipment.

#### COMPENSATION

Compensation shall be for the following Lump Sum Fee: \$179,694.96

## SBE PARTICIPATION

## 1. SCHEDULE 3(A) – Professional Services Activity Report

This form shall be submitted by the prime contractor with each payment application when SBE and/or M/WBE sub-consultants are utilized in the performance of the contract. This form shall contain the names of all SBE and M/WBE sub-consultants, specify the sub-consultants dollar amount for each sub-consultants and show amount drawn and payments to date issued to sub-consultants.

## 2. SCHEDULE 4 – SBE-M/WBE Payment Certification

A schedule 4 for each SBE and/or M/WBE sub-consultant shall be completed and signed by the proposed SBE and/or M/WBE after receipt of payment from the prime. When applicable, the prime shall submit this form with each application submitted to the county for payment to document payment issued to a sub-consultant in the performance of the contract.


