I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to:

A) receive and file U.S. Department of Housing and Urban Development (HUD) FY 2015 Continuum of Care (CoC) Program Grant Agreement No. FL0595L4D051500, for a grant period of twelve (12) months upon receipt of funding; and

B) approve one (1) full-time equivalent (FTE) grant funded position for a Program Evaluator (Pay Grade 34), for the Human Services Division; and

C) approve a budget transfer in the amount of \$23,249 from the General Fund, Contingency Reserves to HUD - Housing and Urban Development fund; and

D) approve a budget amendment in the amount of \$116,246 in the HUD-Housing and Urban Development fund.

Summary: Since 2006, the Division of Human and Veteran Services (DHS) has served as the lead agency for the Palm Beach County Homeless Continuum of Care (CoC) Program. HUD has expanded CoC evaluation requirements for system and project performance monitoring for local, state and federal funding outcomes to ensure accurate reporting and compliance. As a result, this grant agreement will fund one fulltime equivalent (FTE) position for a Program Evaluator and will provide additional funding for the coordination of activities related to ending homelessness. A 25% cash match of \$40,438 is required to be provided by the County. The grant-funded position will be approved for the length of the grant and will be eliminated if funding is discontinued. The required match of \$17,189 is included in the department's FY 2017 budget. The budget transfer in the amount of \$23,249, being requested through this item, represents the remainder of the required match. This grant agreement was executed by delegated authority. On January 26, 2016, the BCC authorized the County Administrator, or designee to execute contracts for this purpose. This grant agreement is being submitted in accordance with Countywide PPM No. CW-O-051 to allow the Clerk's Office to note and receive this item. (DHS) Countywide (HH)

Background and Justification: Beginning in 2002, HUD required CoCs' to implement a single database to track homeless prevention and homeless services provided to individuals and families through local, state and federal funding sources. The Division of Human and Veteran Services works in conjunction with the County's Information Support Systems (ISS) to administer the County's Homeless Management Information System (HMIS), per HUD's requirement. As a result of the 2009 HEARTH Act, HUD implemented CoC Planning projects to provide funds for the collaboration of the CoC, which in Palm Beach County, is known as the Homeless and Housing Alliance (HHA).

In accordance with BCC approval granting signature authority to the County Administrator, or designee, on January 26, 2016 (Agenda Item 3E-3), your signature is needed on the 2015 U.S. Department of Housing and Urban Development (HUD) Continuum of Care Grant Agreement No. FL0595L4D051500. The grant period shall be the date of execution by HUD and is expected that the grant period will be for one (1) year upon receipt of funding. The total grant budget is \$202,190, which consists of \$161,752 from HUD and a required 25% County cash match of \$40,438. The County's cash match FY 2017 budget is \$17,994. As a result of receiving a larger grant award than in the prior year, staff will submit a request for additional County match in the amount of \$22,444 and submit a request for a new grant funded position at the next BCC Commission meeting.

Since 2006, the Division of Human Services has served as the Lead Agency for the Palm Beach County Homeless Continuum of Care (CoC). HUD has recently expanded CoC evaluation requirements for system and project performance monitoring for local, state and federal funding outcomes to ensure accurate reporting compliance. As a result, this grant agreement will fund one (1) full time equivalent (FTE) grant funded position for a Program Evaluator (Pay Grade 34) and provide additional funding for the coordination of activities related to ending homelessness.

Staff will submit the grant agreement at the next available Commission meeting as a "Receive and File" item to allow the Clerk's Office to Receive and File the document in accordance with PPM CW-0-051.

I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to:

A) ratify Signature of the Mayor on the 2015 U.S. Department of Housing and Urban Development (HUD) Palm Beach County Continuum of Care (CoC) Planning Project Application, for the anticipated grant period October 1, 2016, through September 30, 2017, in an amount of \$161,752 for the coordination of planning activities related to ending homelessness; and

B) delegate to the County Administrator, or her designee signatory authority to sign the 2015 CoC Program Grant Agreements for the Palm Beach County CoC Planning Project and any amendments or additional forms.

Summary: The Palm Beach County CoC Planning Project grant will provide funding for the coordination and evaluation of activities related to ending homelessness. These activities involve coordination of monthly Continuum of Care meetings and sub-committee meetings, administration of the Homeless Management Information System, annual preparation of the Continuum of Care HUD grant application, and technical assistance and monitoring of local HUD grant recipients. The actual grant period will be established by HUD. A 25% cash match of \$40,438 is required and will be requested during the FY 2017 budget process. The emergency signature process was utilized because there was insufficient time to submit this application through the regular agenda process. (Human Services) <u>Countywide</u> (HH)

Background and Justification: Since 1996, the Division of Human Services (DHS) has received HUD funds renewable in regular grant cycles. Since 2006, the DHS has acted as the lead agency for the local Continuum of Care. As a result of the 2009 HEARTH Act, HUD has implemented CoC Planning projects to provide funds for the collaboration of the Continuum of Care known in Palm Beach County as the Homeless and Housing Alliance.

CONTINUUM OF CARE PROGRAM GRANT AGREEMENT

This Grant Agreement ("this Agreement") is made by and between the United States Department of Housing and Urban Development ("HUD") and Palm Beach County Board of County Commissioners (the "Recipient").

This Agreement is governed by title IV of the McKinney-Vento Homeless Assistance Act 42 U.S.C. 11301 et seq. (the "Act") and the Continuum of Care Program rule (the "Rule").

The terms "Grant " or "Grant Funds" mean the funds that are provided under this Agreement. The term "Application" means the application submissions on the basis of which the Grant was approved by HUD, including the certifications, assurances, and any information or documentation required to meet any grant award condition. All other terms shall have the meanings given in the Regulation.

The Application is incorporated herein as part of this Agreement, except that only the project listed, and only in the amount listed on the Scope of Work exhibit, are funded by this Agreement. In the event of any conflict between any application provision and any provision contained in this Agreement, this Agreement shall control.

Exhibit 1, the FY2015 Scope of Work, is attached hereto and made a part hereof. If appropriations are available for Continuum of Care grants; if Recipient applies under a Notice of Funds Availability published by HUD; and, if pursuant to the selection criteria in the Notice of Funds Availability, HUD selects Recipient and one or more projects listed on Exhbit 1 for renewal, then additional Scope of Work exhibits may be attached to this Agreement. Those additional exhibits, when attached, will also become a part hereof.

The effective date of the Agreement shall be the date of execution by HUD and it is the date use of funds under this Agreement may begin. Each project will have a performance period that will be listed on the Scope of Work exhibit(s) to this Agreement. For renewal projects, the period of performance shall begin at the end of the Recipient's final operating year for the project being renewed and eligible costs incurred for a project between the end of Recipient's final operating year under the grant being renewed and the execution of this Agreement may be paid with funds from the first operating year of this Agreement. For each new project funded under this Agreement, Recipient and HUD will set an operating start date in eLOCCS, which will be used to track expenditures, to establish the project performance period and to determine when a project is eligible for renewal. Recipient hereby authorizes HUD to insert the project performance period for new projects into the exhibit without Recipient signature, after the operating start date is established in eLOCCS.

This Agreement shall remain in effect until termination either: 1) by agreement of the parties; 2) by HUD alone, acting under the authority of 24 CFR 578.107; 3) upon expiration of the final performance period for all projects funded under this Agreement; or 4) upon the expiration of the period of availability of funds for all projects funded under this Agreement.

Recipient agrees:

- 1. To ensure the operation of the project(s) listed on the Scope of Work in accordance with the provisions of the Act and all requirements of the Rule;
- 2. To monitor and report the progress of the project(s) to the Continuum of Care and HUD;
- 3. To ensure, to the maximum extent practicable, that individuals and families experiencing homelessness are involved, through employment, provision of volunteer services, or otherwise, in constructing, rehabilitating, maintaining, and operating facilities for the project and in providing supportive services for the project;
- 4. To require certification from all subrecipients that:
 - a. Subrecipients will maintain the confidentiality of records pertaining to any individual or family that was provided family violence prevention or treatment services through the project;
 - b. The address or location of any family violence project assisted with grant funds will not be made public, except with written authorization of the person responsible for the operation of such project;
 - c. Subrecipients will establish policies and practices that are consistent with, and do not restrict, the exercise of rights provided by subtitle B of title VII of the Act and other laws relating to the provision of educational and related services to individuals and families experiencing homelessness;
 - d. In the case of projects that provide housing or services to families, that subrecipients will designate a staff person to be responsible for ensuring that children being served in the program are enrolled in school and connected to appropriate services in the community, including early childhood programs such as Head Start, part C of the Individuals with Disabilities Education Act, and programs authorized under subtitle B of title VII of the Act;
 - e. The subrecipient, it officers, and employees are not debarred or suspended from doing business with the Federal Government; and
 - f. Subrecipients will provide information, such as data and reports, as required by HUD; and
- 5. To establish such fiscal control and accounting procedures as may be necessary to assure the proper disbursal of, and accounting for grant funds in order to ensure that all financial transactions are conducted, and records maintained in accordance with generally accepted accounting principles, if the Recipient is a Unified Funding Agency;
- 6. To monitor subrecipient match and report on match to HUD;
- 7. To take the educational needs of children into account when families are placed in housing and will, to the maximum extent practicable, place families with children as close as possible to their school of origin so as not to disrupt such children's education;
- 8. To monitor subrecipients at least annually;
- 9. To use the centralized or coordinated assessment system established by the Continuum of Care as required by the Rule. A victim service provider may choose not to use the Continuum of Care's centralized or coordinated assessment system, provided that victim service providers in the area use a centralized or coordinated assessment system that meets HUD's minimum requirements and the victim service provider uses that system instead;

- 10. To follow the written standards for providing Continuum of Care assistance developed by the Continuum of Care, including those required by the Rule;
- 11. Enter into subrecipient agreements requiring subrecipients to operate the project(s) in accordance with the provisions of this Act and all requirements of the Rule; and
- 12. To comply with such other terms and conditions as HUD may have established in the applicable Notice of Funds Availability.

HUD notifications to the Recipient shall be to the address of the Recipient as stated in the Application, unless HUD is otherwise advised in writing. Recipient notifications to HUD shall be to the HUD Field Office executing the Agreement. No right, benefit, or advantage of the Recipient hereunder may be assigned without prior written approval of HUD.

The Agreement constitutes the entire agreement between the parties hereto, and may be amended only in writing executed by HUD and the Recipient.

- 7. Program income earned during the grant term shall be retained and may either be 1) added to funds committed to the project by HUD and the recipient and used for eligible activities; or 2) used as match.
