#### I. **EXECUTIVE BRIEF**

**Motion and Title: Staff recommends motion to: (A) Accept** on behalf of the Palm Beach County Sheriff's Office, a Department of Justice, Office of Justice Programs FY2017 Enhanced Collaborative Model to Combat Human Trafficking grant award in the amount of \$900,000 for the period of October 1, 2016, through September 30, 2019; **(B) Approve** a budget amendment of \$900,000 in the Sheriff's Grants Fund.

**Summary:** On September 28, 2016, the Palm Beach County Sheriff's Office (PBSO) received a Federal grant award in the amount of \$900,000 to support the development of a multidisciplinary human trafficking task force, related human trafficking investigations, law enforcement training, and communitywide education, to address human trafficking crimes and victimization occurring in Palm Beach County. Funding provided will be used for personnel costs, contractual services, training, data collection, supplies, and community awareness. There is a 25% match requirement of \$300,000 associated with this award. Two PBSO positions are created with this action. Countywide (LDC)

**Background and Justification:** The Enhanced Collaborative Model to Combat Human Trafficking Program, administered by the Office of Justice Programs, supports the development and enhancement of multidisciplinary human trafficking task forces that implement collaborative approaches to combating all forms of human trafficking within the United States, sex trafficking and labor trafficking, of foreign nationals and U.S. citizens. The Department of Justice Office of Justice Programs Catalog of Federal Domestic Assistance (CFDA) Number for this program is 16.320 and the contract number is 2016-VT-BX-K003.

#### SPECIAL CONDITIONS

#### 1. Applicability of Part 200 Uniform Requirements

#### SPECIAL CONDITIONS

4. Requirements related to "de minimis" indirect cost rate

A recipient that is eligible under the Part 200 Uniform Requirements and other applicable law to use the "de minimis" indirect cost rate described in 2 C.F.R. 200.414(f), and that elects to use the "de minimis" indirect cost rate, must advise OJP in writing of both its eligibility and its election, and must comply with all associated requirements in the Part 200 Uniform Requirements. The "de minimis" rate may be applied only to modified total direct costs (MTDC) as defined by the Part 200 Uniform Requirements.

5. Requirement to report potentially duplicative funding

The purpose of this award is to support the development and enhancement of multidisciplinary human trafficking task forces that implement collaborative approaches to combat all forms of human trafficking, including sex and labor trafficking of both foreign nationals and U.S. citizens (of all genders and ages), within the United States. Awards will be made to a lead law enforcement agency and a lead victim service provider within each task force.
