The Water Utilities Department is requesting a new twenty-four and one quarter (24.25) month term contract to provide for the initial phase of the conversion of the County's entire water utilities service area to a fixed base Advanced Metering Infrastructure system, which includes the purchase of meters, transponders, contractor installed communication infrastructure, hosted customer interface software, implementation services, staff training, user manuals, and warranty and maintenance services. \$8,630,859.01 is needed to meet the County's requirements through the expiration of this new twenty-four and one quarter (24.25) month term contract. This contract has no renewal options. Awardee is located in Palm Beach County. This contract was established by a competitive RFP process that allowed up to ten (10) points for SBE participation. No certified SBE participation was offered by the recommended awardee.
