FIRST AMENDMENT TO THE ANNUAL ROADWAY LANDSCAPING CONTRACT PROJECT NO. 2015054 DATED FEBRUARY 9, 2016, BY AND BETWEEN ARAZOZA BROTHERS, CORPORATION AND PALM BEACH COUNTY

THIS FIRST AMENDMENT to the Annual Landscaping Contract, dated February 9, 2016, (R2016-0142), hereinafter "CONTRACT" by and between Arazoza Brothers, Corporation, hereinafter "CONTRACTOR" and Palm Beach County, a political subdivision of the state of Florida, hereinafter, "COUNTY".

- 1. The above recitations are true and correct and incorporated herein.
- 2. It is the intent of the parties hereto that this Amendment shall not become binding until the date executed by the COUNTY.
- 3. The CONTRACT, dated FEBRUARY 9, 2016, between the CONTRACTOR and the COUNTY, is hereby amended to extend the expiration date of the CONTRACT from FEBRUARY 8, 2017 to FEBRUARY 8, 2018.
- 4. All other provisions of the CONTRACT dated FEBRUARY 9, 2016, shall remain in full force and effect.
