The County has received \$443,274 (\$49,253/month) during the previous nine (9) months of the current twelve (12) month term contract. It is anticipated that the County will receive \$531,570 through the expiration of this new twelve (12) month renewal term contract. Penn Credit Corporation will receive sixteen percent (16%) of the revenue collected as their fee. This term contract has no renewal options remaining. Awardee is located out of State. The original contract was established by a competitive RFP process that allowed up to ten (10) points for SBE participation. No certified SBE participation was offered by the recommended awardee.

The County has expended or encumbered \$4,099,567 (\$241,151/month) during the previous seventeen (17) months of the current eighteen (18) month term contract. Due to the County soliciting a new term contract for the pre-qualification of contractors for professional services staffing for ISS, the Purchasing Department is requesting an extension of the current contracts for a three (3) month period through April 30, 2017, or the award of the new contracts, whichever is earlier. ISS is requesting an increase of \$850,000 in order to provide funding for the current staffing positions during the extension period. The pre-qualified contractors provide professional IT Staffing services on an "as needed basis". This term contact has no renewal options remaining. Awarded to three (3) SBE vendors and to five (5) non SBE vendors each utilizing an SBE subcontractor.
