I. EXECUTIVE BRIEF									
Motion and Title: Staff recommends motion to:									
A) approve the listed pre-qualified non-profit pool of agencies to provide various training services for the Community Action Program on an as needed basis selected in accordance with the Request for Proposals (RFP) completed on November 1, 2016; and									
B) delegate signature authority to the County Administrator, or designee, to sign contracts, amendments or required documents for employment and self-sufficiency training services provided by the pre-qualified non-profit agencies for amounts not to exceed \$75,000, and to the Department Director, for amounts not to exceed \$15,000.									
Summary: The Community Action Program issued an RFP for vocational training on October 6, 2016 and the agencies listed in Attachment "A" responded to the request. A selection committee reviewed and scored the proposals. The vocational training funds are provided by the Community Service Block Grant (CSBG), and are allocated according to the amount of funding received every grant year. The agencies selected will provide vocational training to low-income individuals who reside within Palm Beach County. The Community Action Program provides services under several categories including entrepreneurship, employment skills, health and wellness, education, childcare, and life skills. No County funds are required. (Community Action Program) Countywide (HH)									
Background and Justification: The Community Action Program provides vocational training through non-profit entities throughout Palm Beach County for low-income residents. Non-profit entities that provide vocational training are exempt from the purchasing code. In order to maximize participation, the Community Action Program posted a public notice in various locations encouraging agencies to participate in the RFP. Responses were received from the agencies listed in Attachment "A".
