FIRST AMENDMENT TO SIGNATORY AIRLINE AGREEMENT BETWEEN PALM BEACH COUNTY AND AMERICAN AIRLINES, INC

THIS FIRST AMENDMENT TO THE SIGNATORY AIRLINE AGREEMENT (this "Amendment") is made and entered into <u>JAN 172017</u>, 20_, by and between Palm Beach County, a political subdivision of the State of Florida ("COUNTY"), and American Airlines, Inc., a Delaware corporation, having its office and principal place of business at 4333 Amon Carter Blvd., MD 5317, Fort Worth, Texas 76155 ("Airline").

WITNESSETH:

WHEREAS, COUNTY, by and through its Department of Airports (the "Department"), owns and operates the Palm Beach International Airport, located in Palm Beach County, Florida; and

WHEREAS, pursuant to the Signatory Airline Agreement between COUNTY and AIRLINE dated June 13, 2016 (R2016-0974) (the "Agreement"), AIRLINE leases various Airport Terminal facilities and equipment in connection with its operations as a commercial air carrier; and

WHEREAS, the Director of the Department has been delegated the authority to execute certain amendments to the Agreement pursuant to County Resolution No. 2014-1033; and

WHEREAS, the parties desire to amend the Agreement as provided for herein.

NOW, THEREFORE, in consideration of the premises and of the mutual covenants herein contained, and for other good and valuable consideration, the receipt of which the parties hereby expressly acknowledge, the parties hereto covenant and agree to the following terms and conditions:

1. The foregoing recitals are true and correct and are hereby incorporated herein by reference and made a part hereof. Terms not defined herein shall have the meaning ascribed to them in the Agreement.

2. The parties agree that Exhibit "B" to the Agreement (Preferential Use Premises – Terminal Areas) shall be deleted in its entirety and replaced with Exhibit "B" to this Amendment.

3. The parties agree that Exhibit "C" to the Agreement (Preferential Use Premises – Gate Areas) shall be deleted in its entirety and shall be replaced with Exhibit "C" to this Amendment.

4. Exhibits attached hereto and referenced herein shall be deemed to be incorporated in this Amendment by such reference.

5. Except as specifically modified herein, all of the terms and conditions of the Agreement shall remain unmodified and in full force and effect and are hereby ratified and confirmed by the parties hereto.

6. This Amendment shall become effective when signed by both the parties hereto.







EXHIBIT "B" - Preferential Use Premises (Terminal Areas) American Airlines, Inc. Second Level Plan – Palm Beach International Airport







EXHIBIT "C" – Preferential Use Premises (Gate Areas) American Airlines, Inc.
