I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to:

- (A) adopt a resolution approving a Termination Agreement with the Florida Department of Transportation (FDOT) in the amount of \$91,847 for Land Acquisition at Palm Beach County Glades Airport (Pahokee); and
- (B) approve a Budget Amendment of \$91,847 in the Airports' Improvement and Development Fund to terminate a grant from the FDOT, reduce project cost by \$114,808, and add \$22,961 to Reserves.

Summary: On April 5, 2016, the Board adopted a resolution (R-2016-0426 and R-2016-0427) approving a Joint Participation Agreement (JPA) with the FDOT in the amount of \$91,847 for Land Acquisition at Pahokee. The grant expiration date is May 31, 2018. It has been determined that this JPA is no longer needed for this project, therefore, the FDOT has provided a Termination Agreement relieving both parties of any obligations under this agreement. <u>Countywide (AH)</u>

Background and Justification: The above funding was to provide for the acquisition of properties in the Runway Protection Zone (RPZ) on the north end of Runway 17-35 at Pahokee. After several attempts, the Department of Airports has been unsuccessful in obtaining an acceptance of the offer to purchase the property and it is unclear whether or not the County will ever be successful in acquiring this property. As such, the Department of Airports feels it is in the best interest of the County to terminate this agreement and to seek to reallocate the funding to other projects in the future. Discussions with FDOT have indicated their continued efforts to retain these funds for possible future application to other projects undertaken by the Department of Airports.

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, APPROVING A TERMINATION AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION FOR LAND ACQUISITION AT PALM BEACH COUNTY GLADES AIRPORT.

WHEREAS, Palm Beach County, Florida (the "County") through its Department of Airports requested funding for Land Acquisition (the "Project") at Palm Beach County Glades Airport (the "Airport"); and

WHEREAS, the Florida Department of Transportation (FDOT) agreed to participate in the funding of the Project for the Airport; and

WHEREAS, the FDOT provided a Joint Participation Agreement reflecting their commitment of funding in the amount of Ninety One Thousand Eight Hundred Forty Seven Dollars (\$91,847) or 80% of the eligible project costs, whichever is less; and

WHEREAS, It has been determined that funds under this Joint Participation Agreement are no longer needed for this project; and

WHEREAS, It is in the best interest of the County to enter into this Termination Agreement relieving both parties of any obligations under this agreement.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that the Termination Agreement between Palm Beach County and The Florida Department of Transportation, a copy of which is attached hereto and made a part hereof, is hereby approved and the Mayor of the Palm Beach Board of County Commissioners and the Clerk of the Board are authorized to sign same on behalf of the Board.
