I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Work Authorization No. 7 to Hinterland Group, Inc. for Sanitary Sewer Lining Project Wellfield System 8 (Project) in the amount of \$1,040,134.

Summary: On April 15, 2014, the Board of County Commissioners (BCC) approved the Water Utilities Department (WUD) Wastewater Gravity Lines and Manhole Rehabilitation Continuing Construction Contract (R2014-0520) to Hinterland Group, Inc. Work Authorization No. 7 provides for the rehabilitation of approximately 30,000 linear feet of existing wastewater gravity pipes in the Water Treatment Plant No. 8 Wellfield and at other locations within Palm Beach County. The required work will include the cleaning of the lines, video inspection and lining of the lines where necessary. The Small Business Enterprise (SBE) participation goal established by the SBE Ordinance is 15% overall. The Contract with Hinterland Group, Inc. provides for SBE participation of 15%. Work Authorization No. 7 includes 100% overall participation. The cumulative SBE participation to date, including Work Authorization No. 7, is 100% overall. Hinterland Group, Inc. is a Palm Beach County company. This project is included in the FY17 Capital Improvement plan adopted by the BCC. (WUD Project No. 17-016) <u>Districts 2, 3, 5 & 6</u> (MJ)

Background and Justification: Completion of this work will restore the service life of the wastewater system assets, reduce infiltration, restore system capacity and improve the long term operability and reliability of the County wastewater system.



Summary of works to be completed as follows:

- 1. Inspection of gravity main lines and manholes.
- 2. Rehabilitation of 29,971 linear feet of gravity main lines
- 3. Post inspection reports for all rehabilitated assets.

Inspections of manholes and gravity lines will adhere to the following criteria:

Mainline Video Inspections- Header and Inspection form will be completed as per the most recent version of National Association of Sewer Service Companies (NASSCO) Pipeline Assessment Certification Program (PACP). In addition to the required fields the following fields will be completed:

Field 2- Owner

Field 4- Drainage Area Field 9- Time Field 29- Total Length Field 34- Purpose Field 37- Weather Field 41- Project

All NASSCO inspection forms and headers will be exported using PACP, MACP or LACP export option so that the information can be uploaded in Palm Beach County Water Utility Department's (PBCWUD) Granite Net Software. PBCWUD will provide all unique ID's for manholes and line segments.

This project provides for a lot of tuberculation removal and the Contractor must provide video of line segment with the tuberculation removed as the pre-construction video.

COMPENSATION

Compensation shall not exceed <u>\$1,040,134.00</u> in accordance with the unit prices established in the Contract for construction services dated <u>April 15, 2014</u> as approved by the Board of County Commissioners.

SBE PARTICIPATION

SBE participation is included in **ATTACHMENT F** under this Authorization. The attached Schedule 1 defines the SBE applied to this Authorization/Contract and Schedule 2 establishes the SBE contribution from each subcontractor (Letter of Intent to perform as an SBE).

Rates for Liquidated Damages
