I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve:

A) First Amendment to Contract for Community Based Agencies (R2016-1202) with Communities in Schools of Palm Beach County, Inc. (Amendment), with additional funding in an amount of \$30,672, for the period of March 1, 2017 through September 30, 2017; and

B) Budget Transfer of \$30,672 in the General Fund from the Head Start Match reallocation (Unit 1451) for new evidence-based/promising programming to the Communities in Schools' program (Unit 2525) to fund the cost associated with this Amendment.

Summary: Communities in Schools of Palm Beach County, Inc. (CIS) is one of five Youth Violence Prevention agencies that are currently funded to offer a variety of services to youth in order to enhance leadership skills and prevent interaction or further interaction with the juvenile justice system. The Board approved the contracts for Community Based agencies on September 13, 2016 (Contract). The contract with CIS supports the Charting for Success Program to youth at middle and high schools during October 1, 2016 through September 30, 2017. This First Amendment will provide funding for a dedicated academic coach (Coach) to serve up to 30 youth specifically at Lakeshore Middle School. The coach will work one-on-one with the youth at the school from March 1, 2017 through September 30, 2017. Youth are referred based on academic, attendance and behavior needs where evidence-based integrated student supports will assist them in being successful in school and move toward promotion and preparation for high school. District 6 (HH)

Background and Justification: On September 13, 2016, the Board approved a Contract with CIS in the amount not-to-exceed \$71,707, for the period October 1, 2016 through September 30, 2017. The program promotes social and emotional learning, which is an emerging theme/action area of the Youth Master Plan, as well as the School District of Palm Beach County Strategic Plan 2016-2021, to ensure high school readiness, including academic achievement, behavior and engagement.

FIRST AMENDMENT TO CONTRACT FOR COMMUNITY BASED AGENCIES

THIS FIRST AMENDMENT is made as of the _____ day of _____ 2017, by and between Palm Beach County, a political subdivision of the State of Florida, by and through its Board of County Commissioners (COUNTY) and Communities in Schools of Palm Beach County, Inc., a non for profit corporation, authorized to do business in the State of Florida, hereinafter referred to as the AGENCY, whose Federal I.D. is 59-2516164

WITNESSETH:

WHEREAS, the parties entered into a Contract for Community Based Agencies (Contract) dated September 13, 2016, (R2016-1202) in the amount of \$71,707, to fund the Charting For Success Program from October 1, 2016 through September 30, 2017, and with two (2) renewal options; and

WHEREAS, the parties desire to modify the Scope to assign a dedicated Academic Coach at Lakeshore Middle School to work with youth one-on-one, effective March 1, 2017, in the amount of \$30,672; and

WHEREAS, a portion of the funding for the period of October 1, 2016 through September 30, 2017, totaling \$30,672, by this First Amendment, must be allocated toward new evidence-based programming and shall not be allocated toward existing program expenditures.

NOW THEREFORE, the parties mutually agree that the Agreement is amended as follows:

1. The foregoing recitals are true and correct and incorporated herein by reference.
2. **ARTICLE 3 – PAYMENTS TO AGENCY**, the first sentence of the first Paragraph A is hereby replaced with the following:

The COUNTY shall pay to the AGENCY for services rendered under this Contract not to exceed a total amount of ONE HUNDRED TWO THOUSAND THREE HUNDRED SEVENTY-NINE DOLLARS (\$102,379).
3. New **Exhibit A1** is now added.
4. New **Exhibit B2** is now added.
5. All other provisions of the Agreement not modified in this First Amendment remain unchanged and in full force and effect.

SCOPE OF WORK & SERVICE UNITS
FY2017 COMMUNITY BASED AGENCIES CONTRACT

Agency Name: Communities in Schools of Palm Beach County, Inc. (CIS)

Program Name: Charting for Success - Program Amendment

Overview:

The Communities in Schools of Palm Beach County (CISPBC) supports at-risk students in schools throughout Palm Beach County by providing a positive and supportive environment and access to educational opportunities and other social services to help them overcome barriers and make positive life choices. CISBC has an on-going partnership with Palm Beach County whereas a school-based Graduation Coach is hired and stationed at Pahokee High School to interface with school staff, community partners, students and their families to help at-risk youth graduate from high school, and go on to reach their highest potential as successful citizens. This proposed amendment is to request funding to place an Academic Coach at Lake Shore Middle School in Belle Glade, to ensure that Middle School students, at risk of falling behind, receive academic guidance and integrated student support that will ensure high school readiness, academic achievement, positive behavioral change and engagement. This program will have the full support and collaboration of the Principal of Lake Shore Middle School who has indicated his intent to work closely with the Academic Coach to ensure the success of this evidence-based initiative.

Observed Need/Risk Factor(s) that will be addressed: Some Middle School students are not performing to their ability academically and are at risk of falling behind. According to a study conducted by ICF International on behalf of Communities in Schools (CIS) students that received CIS services for two (2) consecutive years had more favorable outcomes than those in the program for one year.

Services:

CISPBC will implement its national evidence based program model, known locally as the Charting for Success (CFS) program using a three tier of service approach:

- **Tier 1** are one-time school wide events based on identified needs. All children in the school participate in the (Tier 1) services. A needs assessment is completed by school administration/staff, students, parents/guardians to determine the need for school wide (Tier 1) resources.
- **Tier 2** are group activities provided to the 30 students assigned to the CISPBC program at Lake Shore Middle School. Students are referred based on academic, attendance and behavior needs and receive evidence based integrated student support to assist them in being successful in school and move toward promotion and preparation for High School.
- **Tier 3** are individual services (one-on-one) based on individual SMART goals set by the students with the Academic Coach. Academic, attendance and behavior achievement goals are set and monitored. The Academic Coach reviews the goals with the students monthly to determine how the student is progressing and if the goal is met another is set.

The program will serve 30 students and will run from March 1, 2017 – September 30, 2017. The following tasks will be completed:

- Hire a school-based Academic Coach to work directly with 30 at-risk Middle School students at Lake Shore Middle School, an approved Title I Middle school;
- Provide training to the Academic Coach through the CIS national office to ensure that the program is compliant with CIS's fidelity standards;
- Record referral source for each youth;
- Assess the needs of each youth and develop an individual action plan;
- Collect student report card data from the School District of Palm Beach County;
- Collect student attendance records from the School District of Palm Beach County;
- Record progress notes with time frames for each contact made with youth
- Upon promotion to High School, refer participants to the Graduation Coach at Glades Central or Pahokee High.

Outcomes:

The following outcomes will be tracked:

- # and % of youth served that demonstrated improvement in student academics;
- # and % of youth served that achieved an increase in attendance;
- # and % of program participants served that improved their conduct in school;
- # and % of program participants served promoted to High School;

Quarterly Reports Submission:

Communities in School of Palm Beach County, Inc. will provide quarterly data for all program participants funded in this contract. Each quarterly report will contain the following information:

- Student school ID #
- Student grades and/or Grade Point Average (GPA)
- Student conduct grade (included in student report card)
- Number of absences out of the total number of days in quarter
- Outcomes, as identified above, tracked as shown on **Exhibit A, Example 1**

Annual Reports Submission:

- Demographic information available as shown on **Exhibit A, Example 2**
