Reginald "Reggie" A. Cox is a licensed architect, building official, state certified plans examiner, and building inspector. He founded Reginald A. Cox and Associates, Inc. in 2006. Mr. Cox is the first African American licensed architect born and raised in Palm Beach County who established an architectural practice. Mr. Cox serves on multiple advisory boards. He is currently the Chair of Delray Beach Community Redevelopment Agency, and he is past Chair of the West Atlantic Redevelopment Coalition. He also served on Delray Beach's Site Plan Review and Appearance Board, Board of Adjustment, Parking Management Advisory Board, and Historic Preservation Board. Cox's interest in architecture began at the age of 12 when he took a wood shop class at Carver Middle School. He graduated from Palm Beach Community College with an associate's degree in design and drafting, and then went on to Florida A&M University, where he earned two bachelor's degrees; a B.S. in Architectural Studies and a B.A. Architecture. He also earned MBA from the University of Phoenix. Mr. Cox is currently pursuing a Master's Degree in Urban and Regional Planning.

Glenn Weiss has spent 25 years assisting counties, cities, museums and community organizations to improve their civic spaces with sculpture, murals, landscape, video and performance. He developed the first comprehensive public art and performance program for NYC's Times Square with 300,000 daily visitors. Glenn also managed the Art of Community Initiative for the Community Foundation of Broward. Weiss has been an art consultant in south Florida preparing public art master plans for numerous cities and counties. Other achievements include management of public art programs for Broward and King counties. He also blogs the Aesthetic Grounds column for ArtsJournal.com. In 2013, his "Dark Serra" - a giant painting in a Houston parking lot - was recognized in the Year in Review by the Public Art Network of Americans for the Arts.
