I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to adopt: a Resolution of the Board of County Commissioners of Palm Beach County, Florida, conveying certain data processing equipment to the City of Belle Glade, pursuant to Section 125.38, Florida Statutes; providing for an effective date.

Summary: The City of Belle Glade (City) provides a Youth Empowerment Center (YEC) as part of the Countywide Youth Violence Prevention Project in partnership with Palm Beach County (R2016-1206). The program provides a safe and secure environment for youth to participate in organized educational and recreational programming. On January 3, 2017, the City requested the County's consideration of the donation of up to 12 desktop computers to include the monitor, keyboard and mouse with each unit. The YEC program computers were on loan from another agency and had recently been removed without notice creating difficulty for participants who rely on the computer equipment to complete homework assignments, vocational and technical training. In accordance with Countywide Policy (CW-O-067), the County Administrator approved the donation of five desktop computers, along with the related accessories, each having an estimated fair market value of \$200, and were accepted by the City on February 27, 2017. These computers are not currently used by Palm Beach County Youth Services and would otherwise be sent to surplus. Approval of this item will authorize the donation of the remaining seven desktop computers requested by the City to the YEC program. District <u>6</u> (HH)

Background and Justification: Palm Beach County Youth Services Department recently replaced these 12 desktop computers as they are no longer under warranty and are on Information Systems Services' list for replacement. Fixed Assets has estimated the fair market value to be \$200 for each desktop unit, including the monitor, keyboard and mouse.

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, CONVEYING CERTAIN DATA PROCESSING EQUIPMENT TO THE CITY OF BELLE GLADE PURSUANT TO SECTION 125.38, FLORIDA STATUTES; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Belle Glade (hereinafter "City"), provides professional services in the area of Youth Violence Prevention through its Youth Empowerment Center (hereinafter "YEC") as part of the Countywide efforts of the Youth Violence Prevention Project in partnership with the County; and

WHEREAS, the City desires and requests that the County convey to it certain data processing equipment owned by County (no County Asset No.) (hereinafter the "Equipment") for the purpose of replacing seven desktop computers, which were on loan to the City from another agency and recently removed; and

WHEREAS, the Board of County Commissioners of Palm Beach County (hereinafter the "Board") is satisfied that the Equipment is required for said use and is not needed for County purposes; and

WHEREAS, the Board is further satisfied that the Equipment has de minimus or no useful value to the County; and that the City's intended use of the Equipment will provide YEC participants with the resources necessary for academic success, as well as educational and vocational trainings.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:
