I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to: approve payment in an amount not to exceed \$9,000 for participation in the 11th Annual Palm Beach Partners Business Matchmaker Conference & Expo to be held on September 22, 2017, in the Kravis Center Cohen Pavilion.

Summary: The Palm Beach County Office of Small Business Assistance, Department of Airports, and Palm Tran are participating with the South Florida Water Management District, School District of Palm Beach County, the City of West Palm Beach, the City of Riviera Beach, the Center for Technology, Enterprise & Development, Inc. (TED Center), and Paragon Florida, Inc., to present the 2017 Business Matchmaker Conference & Expo (a statewide conference). This is the 11th Annual Matchmaker Conference & Expo held in Palm Beach County, and as the chairing entity for this year's event, Palm Beach County will contribute a total of \$9,000 with the County's contribution broken down as follows: the Office of Small Business Assistance — \$3,000, Department of Airports — \$3,000, and Palm Tran — \$3,000. Payment will be made on or before July 7, 2017, to the Center for Technology Enterprise and Development, Inc., the fiscal agent for the conference. The conference and expo will provide Small Business Enterprise owners an opportunity to collaborate with larger businesses in an effort to increase business opportunities and knowledge of programs offered by the above listed governmental and non-profit partners. **Countywide** (HH).

Background and Policy Issues: On September 22, 2017, the Palm Beach Partners will present the 11th Annual 2017 Business Matchmaker Conference & Expo in the Kravis Center Cohen Pavilion. This event will feature workshops and seminars that will provide information to Small/Minority/Women Business Enterprise (S/M/WBE) owners. Additionally, one-on-one business matchmaking appointments will be made available for conference participants to meet with key staff from Palm Beach County, the South Florida Water Management District, School District of Palm Beach County, the City of West Palm Beach, the City of Riviera Beach, the Center for Technology Enterprise & Development, Inc. (TED Center), and Paragon Florida, Inc.
