

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, ABANDONING ANY PUBLIC INTEREST IN A PORTION OF THE UNIMPROVED POSTED AND VIEWED RIGHT-OF-WAY PER PALM BEACH COUNTY COMMISSION MEETING 4/4/1916 LYING IN SECTION 34, TOWNSHIP 40 SOUTH, RANGE 42 EAST, BEING THE NORTH 25 FEET OF TRACT "A" ACCORDING TO THE PLAT OF ELS CENTER OF EXCELLENCE AS RECORDED IN PLAT BOOK 117, PAGES 147 THROUGH 148, PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA, TOGETHER WITH THE NORTH 25 FEET OF RIGHT-OF-WAY OF THE EAST 300 FEET OF THE WEST 330 FEET OF THE SOUTHWEST QUARTER OF SAID SECTION 34.

WHEREAS, the Board of County Commissioners (BCC) of Palm Beach County, Florida, pursuant to authority in Section 336.09, Florida Statutes, and as provided in Palm Beach County (County) Code Chapter 22. Article III, Road Abandonment and Plat Vacation (Ordinance No. 2002-034), known as the Palm Beach County Right-of-Way Abandonment and Plat Vacation Ordinance, and the petition of the Els for Autism Foundation, called a public hearing to be held in the BCC's Chambers, at the Governmental Office Complex, West Palm Beach, Florida, on June 20, 2017, to consider and determine whether or not the County would vacate, abandon, discontinue and close, renounce and disclaim any right or interest of the public in and for a portion of the posted and viewed right-of-way per Palm Beach County Commission meeting 4/4/1916 lying in Section 34, Township 40 South, Range 42 East, being the north 25 feet of Tract "A" according to the plat of Els Center of Excellence as recorded in Plat Book 117, Pages 147 through 148, public records of Palm Beach County, Florida, together with the north 25 feet of right-of-way of the east 300 feet of the west 330 feet of the southwest quarter of said Section 34; as set forth on the sketch and legal description set forth in Exhibit A attached hereto and incorporated herein by reference, all of the Public Records of Palm Beach County, Florida; and




