## I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to:** approve a Settlement Agreement, inclusive of attorney's fees and costs, in the total amount of \$70,000 in the personal injury action styled Gary Tahal vs. Palm Beach County Board of County Commissioners, Case No. 502015CA007132XXXXMB.

**Summary:** On August 24, 2012, the plaintiff was traveling south on Haverhill Road approaching the intersection with Melaleuca Lane. A WUD employee in a County van made a left turn in front of plaintiff causing an accident. **Countywide (SCL)**

**Background and Justification:** On August 24, 2012, the plaintiff was traveling south on Haverhill Road approaching the intersection with Melaleuca Lane. A Water Utilities Department employee in a County van made a left turn in front of plaintiff causing an accident. The County employee was assessed 2 points (avoidable). The plaintiff alleges injuries to his head, neck, back, and left shoulder. He underwent surgery for two tears in his left shoulder followed by several weeks of physical therapy. He complains of residual pain in his shoulder and an inability to perform several activities. Plaintiff's medical expenses total in excess of \$47,000.

Therefore, it is recommended that the County approve the Settlement Agreement in the amount of \$70,000.





## SETTLEMENT AGREEMENT

THIS AGREEMENT made and entered into this 9<sup>th</sup> day of June, 2017, by and between PALM BEACH COUNTY BOARD OF COUNTY COMMISSIONERS, (the "COUNTY"), a political subdivision of the State of Florida, and GARY TAHAL.

WHEREAS, GARY TAHAL sued the COUNTY in a lawsuit presently styled Gary Tahal v. Palm Beach County Board of County Commissioners, Case No. 502015CA007132XXXXMB, in the Circuit Court of Palm Beach County, Florida (the "Pending Lawsuit"), for damages arising from a motor vehicle accident that occurred on August 24, 2012, at or near the of intersection of Haverhill Road and Melaleuca Lane in Greenacres, Florida;

WHEREAS, the "COUNTY" has denied liability and raised several affirmative defenses in the Pending Lawsuit; and

WHEREAS, the parties hereto wish to amicably resolve that portion of the Pending Lawsuit that involves the "COUNTY" without further litigation of the claims made and defenses raised therein.

NOW, THEREFORE, in consideration of the mutual covenants hereinafter set forth, the sufficiency of which are hereby acknowledged, the parties agree as follows:

1. The foregoing recitals are true and correct and incorporated herein by reference.
2. Within a reasonable time of full execution and receipt hereof of this settlement agreement, and subject to final administrative approval, the COUNTY shall pay to Gary Tahal the amount of Seventy Thousand Dollars (\$70,000.00), by a check made payable to Goldman & Daszkal Trust Account f/b/o Gary Tahal, whose Tax I.D. No. is 65-0224682.
3. Within ten (10) days of receipt of the COUNTY'S payment, Nathan Hoy, Esq., shall execute and deliver to the Palm Beach County Attorney's Office (i) a Release of All Claims in the form of the attached hereto, and (ii) the Stipulation and Final Order of Dismissal with Prejudice, in the form of the attached hereto, which, in turn, the Palm Beach County Attorney's Office will file with the court.
4. Nathan Hoy, Esq. shall not disburse, and Gary Tahal shall not accept, any proceeds from the settlement check described in paragraph 2 unless and until the Release of All Claims has been delivered to the COUNTY and the Final Order of Dismissal with Prejudice has been filed in accordance with paragraph 3 above.
5. Gary Tahal acknowledges and agrees that he is responsible for the payment of any liens, including any/all outstanding medical bills, against this settlement and that the COUNTY shall not be responsible for any portion of said liens or medical bills. Gary Tahal on behalf of himself and his officers, agents, employees, heirs, executors, administrators and assigns, further agrees to indemnify, defend, and hold the COUNTY, its officers, agents, elected officials, employees, heirs, executors, administrators and assigns, harmless from and against all suits, actions, proceedings,

claims, demands, and damages, including attorneys fees, arising out of or related to such liens or claims of lien.

6. Each party shall bear its respective attorneys fees and costs.

7. This Settlement Agreement does not constitute an admission of liability by any party.

8. In any litigation brought to enforce the terms or remedy a violation of this Settlement Agreement, the prevailing party shall be entitled to an award of reasonable attorney's fees in addition to any other recovery.


9. Gary Tahal declares and acknowledges that the terms of this Settlement Agreement have been completely read, fully understood, discussed with counsel, and voluntarily accepted as a full and final compromise of any and all claims they may have against the COUNTY arising out of or relating to the aforementioned accident.


10. This Settlement Agreement shall be binding on the parties hereto, their assigns, transferees, heirs, and other successors in interest.

11. The parties represent that no claim that has been, or could have been, raised in the Pending Lawsuit, and no claim to which this Settlement Agreement applies, has been assigned or otherwise transferred to any other person or entity not a party hereto.



## RELEASE OF ALL CLAIMS

### **KNOW ALL MEN BY THESE PRESENTS:**

That the undersigned, GARY TAHAL, being of lawful age, for the sole consideration of **SEVENTY THOUSAND DOLLARS AND ZERO CENTS (\$70,000.00)**, to the undersigned in hand paid, the receipt and sufficiency whereof is hereby acknowledged, does hereby and for their executors, administrators, successors and assigns, release, acquit and forever discharge **PALM BEACH COUNTY BOARD OF COUNTY COMMISSIONERS**, (hereinafter referred to as the Releasees), and their officers, agents, employees, heirs, executors, administrators, successors and assigns, none of whom admit any liability to the undersigned, but all of whom expressly deny any such liability, from any and all claims, demands, rights, damages, costs, loss of service, expenses, compensation, actions, causes of action or suits of any kind or nature whatsoever, which the undersigned may now have or which may hereafter accrue or develop, particularly on account of or in any way growing out of any and all known and unknown, foreseen and unforeseen, bodily and personal injuries, and property damages, and any and all consequences thereof, resulting or to result from an alleged incident that occurred on or about August 24, 2012, at or near the of intersection of Haverhill Road and Melaleuca Lane in Palm Beach County, Florida.

**FURTHERMORE**, the undersigned agrees that each party shall bear their own costs and attorney's fees, and the undersigned shall bear sole responsibility for any and all hospital, physician, diagnostic, rehabilitation, training, maintenance, medical or pharmaceutical expenses, bills, statements, liens or subrogable interests, of any nature whatsoever, which are or may be outstanding and payable on the date of execution of this agreement, or which may be incurred and payable in the future. The undersigned further agrees to indemnify and save harmless the Releasees from any requests for payment or attempts for collection therefrom. Should legal action be instituted against the Releasees for payment or collection of the aforementioned expenses, the undersigned agrees to indemnify and save harmless the Releasees for any attorney's fees, costs and/or judgments which may be entered against the Releasees.

**FURTHERMORE**, the undersigned understands and agrees that this settlement is the compromise of a doubtful and disputed claim, and that the payment made shall not be construed as an admission of liability on the part of the Releasees, and that the Releasees deny any liability therefor and merely intend to avoid further litigation and buy their peace.

**FURTHERMORE**, the undersigned hereby declares and represents that any injuries sustained are or may be permanent and progressive and that recovery therefrom is uncertain and indefinite and in making this Release the undersigned understands and agrees that the undersigned relied wholly upon the undersigned's own judgment, belief and knowledge of the nature, extent, effect and duration of any injuries and liability therefore, without reliance upon any statement or representation by the Releasees, or by their representatives or by any physician or surgeon employed by them. The undersigned further declares and represents that no promise, inducement or agreement not herein expressed has been made to the undersigned, and that this Release contains the entire agreement between the parties hereto, and that the terms of this agreement are contractual and not merely a recital.

**FURTHERMORE**, the undersigned states that while they hereby release any and all claims

against the Releasees, and their officers, agents, employees, heirs, executors, administrators, successors and assigns, for both past and future losses, including medical expenses, health care expenses and related expenses, the necessity for future medical treatment and expenses incurred is speculative and unknown at this time and therefore, as a result, the undersigned reserves the right to pursue and recover all future medical expenses, health care expenses and related expenses, from any person, firm, or organization who may be responsible for payment of such expenses, including any first-party health or automobile insurance coverage, but such reservation specifically does not include the Releasees.

**FURTHERMORE**, notwithstanding the language contained in this Release, this release shall not be construed as releasing any medical providers for potential claims which may arise based upon treatment and care rendered as a result of the accident which is the subject of this Release. Moreover, this Release shall not be construed as releasing any health insurance carrier or other insurer from medical and lost wage benefits to which the Releasor is entitled.

**THE UNDERSIGNED** hereby declares that the undersigned has completely read, fully understood and voluntarily accepted the foregoing Release of All Claims for the purpose of making a full and final compromise settlement and adjustment of any and all claims, disputed or otherwise, on account of the injuries and damages set forth above, and for the express purpose of precluding forever any further or additional claims against the Releasees arising out of the aforementioned incident.

**THE UNDERSIGNED** hereby accepts the tendered settlement draft as final payment of the consideration set forth above.




