I. EXECUTIVE BRIEF

Motion and Title: Staff recommends a motion to approve: Assignment of Rights to Refund of Sales Tax by the Florida Department of Revenue (FDR) to Delta Air Lines, Inc. (Delta).

Summary: Delta is seeking reimbursement from the FDR for sales tax paid on certain airport space rentals at Palm Beach International Airport. The approval form will allow the FDR to review Delta's reimbursement claim and, if approved, to reimburse Delta directly for sales tax Delta originally paid. Delta agrees to provide the County with documentation supporting the taxability pertaining to the claim. Delta is a customer in good standing with the County and promptly pays all invoices including sales tax; therefore, staff recommends allowing Delta to seek this reimbursement. **Countywide (AH)**

Background and Justification: The Department of Airports invoices tenants for airport terminal rental plus applicable sales tax and subsequently remits sales tax to the FDR. FDR regulations contain tax exemptions for certain aviation facility rentals but require the tax payer to prove that circumstances meet the exemption criteria. The attached approval allows Delta to pursue this claim and be directly reimbursed for payments that Delta made.

ASSIGNMENT OF RIGHTS TO REFUND OF SALES TAX

Dealer Registration Number: 60-8012091272-8

Palm Beach County ("County") by and through its Department of Airports, owns and operates the Palm Beach International Airport, located in Palm Beach County, Florida ("Airport"). Delta Air Lines, Inc. ("Delta") rents space from the County at the Airport, pursuant to Delta's Airline-Airport Use and Lease Agreement with the County ("Agreement"). Delta is required to pay sales and use taxes to the County for the rental of airport space in accordance with the Agreement. The County thereafter remits Delta's sales and use taxes to the Florida Department of Revenue ("FDR"). The County acts as a collection agent for the FDR and agrees that it has no rights to the value of use and sales taxes collected from Delta. The County and Delta agree that any reimbursable sales and use taxes which Delta recovers from the FDR relating to the rental of airport space totaling \$182,699.83 and occurring during the period of September 1, 2012 through December 31, 2015 is the property of Delta and not the County. Delta agrees to cooperate with the County in providing the County information Delta receives from the FDR supporting the taxability or non-taxability of rented space at the Airport; provided, however, that Delta shall not be required to provide to the County any documentation that contains confidential taxpayer information.
