# I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to approve:** a Contract with All Webbs Enterprises Inc., for the GL01 Water Treatment Plant 11 (WTP 11) Production Well 11 Well and Wellhead Project (Project) in the amount of \$1,469,205.

**Summary:** On April 12, 2017, three (3) bids were received for the Project to construct a new Floridan Aquifer Production Well 11 (PW-11). All Webbs Enterprises, Inc., was determined to be the lowest responsive, responsible bidder in the amount of \$1,469,205. PW-11 is needed to maintain adequate wellfield capacity to meet the potable water treatment demands at WTP 11. PW-11 will provide an additional 900 gallons per minute (gpm) of raw water to WTP 11 and provide for improved wellfield management practices. The Project is being partially funded by a Congressional appropriation in the form of a grant administered by the United States Environmental Protection Agency in the amount of \$485,000. Pursuant to federal law (2 CFR 200.321), All Webbs Enterprises, Inc., was required to undertake good faith efforts to meet Disadvantaged Business Enterprise goals for federally funded projects and the County is preempted from utilizing its local SBE ordinance. All Webbs Enterprises, Inc., has undertaken the good faith efforts necessary to satisfy the federal requirements to take all necessary and affirmative steps to assure that minority and women's business enterprises are used where possible. All Webbs Enterprises Inc., is a Palm Beach County company. This project in the FY17 Capital Improvement Plan adopted by the Board of County Commissioners (BCC). (WUD Project No. 15-058) District 6 (MJ)

**Background and Justification:** On June 21, 2011, the BCC approved a comprehensive plan to stabilize the declining raw water quality at WTP 11. On August 2, 2015, the Contract Review Committee approved Consultant Services Authorization (CSA) No. 7 for Kimley-Horn and Associates, Inc., to provide surveying, hydrogeological and detailed design services for PW-11 to serve WTP 11. PW-11 is a new Upper Floridan Aquifer production well that will provide an additional 900 gpm of raw water to WTP 11. PW-11 will also assist with improved wellfield management practices allowing plant operations staff to rest wells for longer periods of time and also balance raw water quality being treated by WTP 11. The Project includes the drilling and construction of the raw water production well as well as the installation of a submersible well pump and motor with variable frequency drive variable frequency drive, column pipe, wellhead facilities, electrical supply, instrumentation and above ground site facilities such as lighting and fencing. The bid review comments for the three (3) lowest proposals is detailed in attachment 3. The irregularities provided no competitive advantage.



The bid opening for the above referenced project was held on Wednesday, April 12, 2017. Proposals were received from three (3) contractors. The complete Bid Tabulation is attached. The Engineer's opinion of probable construction cost was \$1,909,270.00. The low bidder is All Webbs Enterprise Inc. with a construction cost of \$1,469,205.00 for the bid.

An evaluation of the low bid by All Webbs Enterprise Inc. is as follows:

- 1. The first low bidder, All Webbs Enterprise Inc., provided properly executed Bid Forms in the Contract Documents.
- 2. Bid security equal to 5% of the total base bid was enclosed with the bid.
- 3. The project is partially funded by an XP grant administered by the United States Environmental Protection Agency and therefore uses the Disadvantaged Business Enterprise requirements for federally funded projects and not PBC's Small Business Enterprise requirements, as such there is no OSBA review required for the project.
- 4. The County Attorney (CAO) has reviewed the bid and Bid Review Comments for the three (3) lowest bids. For All Webbs Enterprise Inc., no major irregularities were identified. (See attached Bid Review Comments and email from CAO's Michael Jones dated April 27, 2017).
- 5. There were three (3) addenda issued for this project. All Webbs Enterprise Inc. acknowledged the three addenda.

- 6. All Webbs Enterprise Inc. holds valid contractor and occupational licenses. All Webbs Enterprise Inc. had a valid Palm Beach County business tax receipt at the time of the bid submittal (See attached Palm Beach County Tax Collector receipt.).
- 7. The first low bidder, All Webbs Enterprise Inc., holds a principal place of business in Palm Beach County. The contractor holds a valid state water well and general contractor licenses (See Attached No.5 for license information).

Contract award is recommended to the lowest responsive bidder, All Webbs Enterprise Inc., in the amount not to exceed \$1,469,205.00 for the bid, subject to formal approval by the PBC Board of County Commissioners. 


