#### SECOND AMENDMENT TO AGREEMENT

THIS SECOND AMENDMENT to Interloc	al Agreement R2014-0594 dated May 6, 2014 and
as amended by the First Amendment dated Octobe	r 17, 2014, collectively referred to herein as the
"Agreement", is made as of	, by and between Palm Beach County, a
political subdivision of the State of Florida, by an	nd through its Board of County Commissioners
("County") and Town of Ocean Ridge, a municipal c	orporation of the State of Florida ("Participant").

In consideration of the mutual promises contained herein, the County and Participant agree as follows:

- 1. The term of the Agreement is expiring on October 31, 2017, and shall be extended through October 31, 2021, pursuant to the exercise of the four (4) year renewal option.
- 2. Section 19 of the Agreement is deleted in its entirety and replaced with the following:

#### **SECTION 19: NON-DISCRIMINATION**

Pursuant to Resolution R-2014-1421, as amended, it is the policy of the Board of County Commissioners of Palm Beach County that Palm Beach County shall not conduct business with nor appropriate any funds to any organization that practices discrimination on the basis of race, color, national origin, religion, ancestry, sex, age, familial status, marital status, sexual orientation, gender identity and expression, disability, or genetic information.

The Participant has submitted to County a copy of its non-discrimination policy which is consistent with the above paragraph, as contained in Resolution R-2014-1421, as amended, or in the alternative, if the Participant does not have a written non-discrimination policy, it has affirmed through a signed statement provided to County that Participant will conform to the County's non-discrimination policy as provided in R-2014-1421, as amended.

3. Except as modified by this Second Amendment, the Agreement remains unmodified and in full force and effect in accordance with the terms thereof.
