Summary: On April 3, 2017, the Youth Services Department issued a Request for Proposals (RFP) for Community Based Agencies (CBAs) FY 2018 for four (4) Action Areas identified as priorities in the Youth Master Plan: Economic Access, Parenting and Role Models, Social and Emotional Learning Supports, and Ensuring Safety and Justice. On July 11, 2017, the Board of County Commissioners conceptually approved the recommended funding allocations to the above agencies. Funding for the CBAs comes from the Head Start reallocation money identified for evidence-based and promising practices. The effective dates of services for the above contracts submitted for approval are prior to this meeting date. **Continued on Page 3**

Summary: Olga Sierra, an employee of Vita Nova, Inc., Patrice Huntley, an employee of Compass, Inc. and Jeannette Tomici, an employee of Children's Case Management Organization, Inc. are members of the Palm Beach County HIV Care Council. Joshua Butler, an employee of Gulfstream Goodwill Industries, Inc. is a member of the Homeless Advisory Committee. Patrick Franklin, an employee of The Urban League of Palm Beach County, Inc. is a member of the Housing Finance Authority and the Infrastructure Surtax Independent Citizen Oversight Committee. These boards provide no regulation, oversight, management or policy-setting recommendations regarding the contracts listed above. Disclosure of these contractual relationships at a duly noticed public meeting is being provided in accordance with the provisions of Section 2-443, of the Palm Beach County Code of Ethics. <u>Countywide (HH)</u>

Background and Justification: On June 3, 2014, the Board approved an Interlocal Agreement with the Children's Services Council of Palm Beach County to provide cooperative program support and local matching funds to the Head Start program, currently administered by Lutheran Services Florida. The Interlocal Agreement obligates the County to invest in additional evidence-based/promising programming and services for youth and young adults. The amount required to be invested in FY18 is \$3.0 million. The contracts recommended for funding under this RFP total \$2,190,500. In addition to these contracts, \$236,765 is allocated to the Back to a Future re-entry program administered by Public Safety, \$32,855 for the remainder of the contract with ANDRUS Sanctuary Institute for the implementation of the Trauma Informed Care program at the Highridge Family Center and YSD will be recommending \$275,984 for Prime Time After School Quality Improvement Program, \$135,000 for Summer Internship programs at the three (3) Youth Empowerment Centers, and \$50,000 to fund adoption services with Children's Home Society. This leaves \$118,896, plus any carryover dollars from FY17 allocations to commit during FY18.

The Board approved a Contract with Forum for Youth Investment Corp. on December 15, 2015, for the creation of a collaborative Youth Master Plan (YMP), which was published in November 2016 and presented to the Board in a workshop on January 24, 2017, along with the recommended funding areas. The YMP identified six (6) priority areas. For FY18, four (4) areas were selected for funding pursuant to the issuance of the RFP. Collectively, there were 52 proposals received covering all four (4) Action Areas. The proposals were initially reviewed for responsiveness. Proposals meeting minimum requirements were then reviewed by panels consisting of YSD staff and community experts. Each Review Panel scored the proposals by Need, Approach and Design, Evaluation Approach, Available Resources and Sustainability, and Budget. Review teams also ranked proposals based on the criticality of the services. YSD staff made the final recommendations utilizing the Review Team scoring and ranking, knowledge of other funding availability and a review of budget needs and available resources.

On July 11, 2017, the Board of County Commissioners conceptually approved the recommended funding allocations. A summary of each agency's services, districts served, and Action Area is identified in Attachment 2 to this Agenda Item.
