





**AMENDMENT  
TO  
CONTRACT  
BETWEEN  
PALM BEACH COUNTY  
AND  
PEGGY ADAMS ANIMAL RESCUE LEAGUE, INCORPORATED**

This Amendment is made as of the \_\_\_\_\_ day of \_\_\_\_\_, 2017, by and between Palm Beach County, a Political Subdivision of the State of Florida, by and through its Board of Commissioners, hereinafter referred to as the COUNTY, and Peggy Adams Animal Rescue League of the Palm Beaches, Incorporated, a Florida non-profit corporation authorized to do business in the State of Florida, hereinafter referred to as PAARL., both hereinafter referred to collectively as the parties.

**WITNESSETH:**

WHEREAS, on November 22, 2016, the parties entered into a contract (R-2016-1726) for PAARL to spay/neuter, vaccinate, microchip and provide other services to selected at risk dogs and cats transferred or referred to PAARL by the COUNTY; and

WHEREAS, the Agreement provided that PAARL would provide services until September 30, 2019, and that the County would provide funds to PAARL in an amount not to exceed \$600,000; and

WHEREAS, the County wishes to increase the total amount of its payment to PAARL by an additional \$120,000 for a total not to exceed amount of \$720,000 to account for the additional services to be provided under this Amendment.

**NOW, THEREFORE**, in consideration of the mutual promises contained herein and for good and valuable consideration, the parties agree as follows:

1. The foregoing recitals are true and correct and incorporated herein.
2. Article 3, entitled Payment to PAARL, subsection A., is hereby deleted in its entirety and replaced with the following:

The total amount to be paid by the COUNTY under this Contract for all services and materials including, if applicable, "out of pocket" expenses (specified in paragraph C below) shall not exceed a total contract amount of Seven Hundred and Twenty Thousand Dollars (\$720,000). For each fiscal year of this Contract, which runs from October 1<sup>st</sup> to September 30<sup>th</sup> of the following year, payment to PAARL shall not exceed Two Hundred and Forty Thousand Dollars and 00/100 (\$240,000) unless funds are carried over from a previous year. During each fiscal year, PAARL shall notify the COUNTY's representative in writing when services totaling \$216,000 have been provided by PAARL. PAARL will bill the COUNTY on a monthly basis, or as otherwise provided, at the amounts set forth in Exhibit "B" for services rendered toward the completion of the

Scope of Work. Where incremental billings for partially completed items are permitted, the total billings shall not exceed the estimated percentage of completion as of the billing date.

3. Except as expressly provided herein, all terms and conditions of the Contract remain in full force and effect.

**IN WITNESS WHEREOF**, the Board of County Commissioners of Palm Beach County, Florida has made and executed this Contract on behalf of the COUNTY and PAARL has hereunto set its hand the day and year above written.
